
Board had shortlisted 12 candidates for appearing in Tier-II examination for the post of PGT (Physical Education) (Female) in Directorate of Education under postcode 174/2014 vide result notice number CC-I/380 dated 26.05.2015. The Tier-II examination for the post of PGT (Physical Education) held on 28.06.2015 was cancelled vide Notice dated 03.11.2015. The said examination was again held on 26.06.2016, wherein 11 candidates appeared. Marks of the candidates have been uploaded on Board's website. The candidates can view their marks by logging into their account in OARS module on <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>.

2. Based on the performance in Tier-II examination held on 26.6.2016, **10 candidates** as detailed below have been provisionally allowed to upload e-dossiers in the ratio of 1:2 of the advertised vacancy subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms/OARS.
