The DSSSB vide its advertisement no. 01/2015 with closing date 26/11/2015 had advertised 152 vacancies (UR-51, OBC-34, SC- 35, ST-32 including 54 EXSM) for the Post of Warder under post code 62/15 in Delhi Prison Department. The Board had conducted Physical Endurance Test (PET) for the applicants of the post code from 04/02/2019 to 15/03/2019 (34 days) at CHHATRASAL STADIUM, MODEL TOWN, RING ROAD, DELHI-110009.

On qualifying PET, 2966 candidates were provisionally allowed to appear for written examination for post code 62/15, subject to correctness of the information furnished by the candidates in their online application forms.

The online examination was held on 27/06/2019. The marks statement of the above Post/Post Code has been uploaded on the Board's website for information of the candidates. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.

The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Certificates and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex-Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.

*The Candidate having Roll Number 11160500204 having date of birth 24/12/1991 being older in age than other candidates having equal marks has been shortlisted for filing up of dossier.

**The Candidate having Roll Number 12350500896 having date of birth 10/08/1994 being older in age than other candidates having equal marks has been shortlisted for filing up of dossier.

The link for up-loading e-dossier shall be kept open for a period of 15 days with effect from 12/09/2019 to 26/09/2019. The candidates uploading e-dossier should ensure that

he fulfills all the eligibility criteria as on the cutoff date, i.e., 26/11/2015. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number and e-mail ID. If any candidates fails to upload the e-dossier during the above said period, his candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever grounds.

Mere asking the candidate for up-loading documents in the e-dossier module does not confer his any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned above he will not be given any further opportunity and his candidature will be treated as cancelled.
