RESULT NOTICE NO. 680

MATRON IN DELHI PRISONS DEPARTMENT (POST CODE-36/13)

- 1. The DSSSB vide its advertisement No. 02/2013 with closing date 02.08.2013, 81 vacancies (UR-41, OBC-22, SC-12, ST-06 out of which 08 vacancies were reserved for EXSM) for the post of Matron in Delhi Prisons Department. The Board had conducted the written examination on 02.03.2014 for the post of Matron (Female) under postcode 36/13. After conducting the Physical Endurance test (PET-I) in respect of shortlisted candidates from 16.3.2015 to 22.3.2015, the final result was declared vide result notice number 343 dated 6.11.2015 and subsequent result notices number 366 dated 11.1.2016 and result notice number 383 dated 13.04.2016. Later further candidates were shortlisted candidates to appear for PET-II to fill up the unfilled vacancies. PET-II was conducted on 14.07.2016, on qualifying the PET-II, the final result was declared vide result notice number 417 dated 29.7.16 and subsequent result notices number 479 dated 3.3.17.
- 2. Further vide notice number 534 dated 22.08.2017 additional 49 candidates were shortlisted for appearing in PET-III against the unfilled vacancies of the post. The PET-III was conducted on 16.02.2018 and its result was declared vide notice number 650 dated 07.05.2018. In the PET-III only one candidate having roll number 13001429 had qualified the PET. Accordingly the e-dossier of the said candidate was also called simultaneously vide notice dated 07.05.2018 to upload her documents latest by 24.05.2018. The e-dossier link was further extended upto 03.06.2018 vide notice number 654 dated 24.05.2018.
- 3. The candidate having roll number 13001429 has not uploaded any documents in e-dossier link, accordingly her candidature is hereby cancelled.
- 4. In view of same there is no selection to the post Matron (Female) under postcode 36/13 on the basis of PET-III.
- 5. The dossiers of selected candidates having roll number 13001465 (Kalindi Gupta), 13001210 (Nitika), 13003129 (Jyoti), 13003692 (Dipiki Gupta), 13001448 (Khusbu) & 13002450 (Kavita) were returned vide Prisions Department Letter dated 1.12.2017 after cancelling their candidatures as they have not joined the post. Further dossier of selected candidate having roll number 13001628 (Pooja Sharma) was returned vide Prisons Department Letter dated 1.5.2018 after cancelling her candidatures as she has not joined the post.



6. After conduct of PET-II the cut off marks of selection to the post under UR category were reduced to 113.25 to 91 marks, accordingly the 12 candidates who were selected in OBC and ST category on the basis of PET-I having marks above 91 without seeking any relaxation are hereby shifted to UR category from OBC and ST category.

- 9. No further candidate is available in OBC, SC and EXSM category above minimum qualifying marks for shortlisting.
- 10. The above 51 candidates have been shortlisted for appearing in PET-IV on the basis of details provided by them in their on line application form OARs. Since document have not been called from the candidates along with application, as such detailed scrutiny regarding their eligibility and admissibility of reservation benefit have not been carried out and therefore mere inclusion of the candidate in the list for qualifying candidates for appearing in PET-IV does not entitle his right over the post.
- 11. Additionally shortlisted candidates shall be separately informed about the date and venue of PET-IV.
- 12. Candidates who remained absent during PET conducted earlier have not be included in the PET-IV.
- 13. Final selection against unfilled vacancies shall be made in accordance with merit list drawn as per result of written examination subject to availability of vacancies and the candidates qualifying the PET-IV and also fulfilling of all conditions of eligibility as prescribed by the RRs, admissibility of reservation benefits and terms and conditions advertised.



14. While every care has been taken in short listing the candidates for appearing in PET-III, DSSSB reserves the right to rectify errors and omissions if any detected at any stage.
