In continuation to the previous Result Notice No. 344 dt. 5/12/2014 and Result Notice No. 367 dt. 16/4/2015, on the basis of written examination held on 02-02-2014 and eligibility regarding educational qualifications, age etc. as per Advertisement No. 004/09 and RRs for the post of Teacher (Primary), MCD, Post code 70/09, the following candidates are provisionally selected and recommended for appointment to the post of Teacher (Primary), post code 70/09 in MCD. This is subject to outcome of Court cases/CAT cases pending in respect of this post code.



The selection of the above 59 Candidates (UR: 17, OBC: 08, SC: 15, ST: 17, UR (OH): 02) shall further be subject to fulfilment of all the eligibility conditions as prescribed by the statutory RRs and terms and conditions of advertisement as indicated in the advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/ handwriting etc. On the application form, admission certificate etc. The candidature of the candidates are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the eligibility conditions or due to any other genuine reason. The Competent authority of the department concerned shall issue the appointment letter to the candidate after satisfying themselves of their eligibility as laid down in the Recruitment Rules and on verification of the correctness of the information/documents/caste certificate furnished in the application forms. Further, the recognition of the universities from which the degree/ diploma/ certificates have been submitted by the candidates should also be verified. **Mere inclusion of name in the result notice does not confer any right upon the candidates over the post. The selection/appointment of above mentioned candidates shall further be subject to outcome of any court case.**

Further, as per judgement of Hon'ble High Court of Delhi in the matter of Sachin Gupta & Ors V/s. DSSSB passed in WP(C)7297/2007, the one time opportunity in age relaxation has been given to those candidates who have passed their ETE in the year 2006 or 2007 or 2008.

The Addl. Dy. Commissioner, Education Deptt., MCD vide letter No.D /ADE/TRC/Edu /HQ/ 2011/1476 dated 25/11/2011 informed that one time age relaxation will be given to 347 teachers working on contract basis in MCD.

This is also informed that as per instructions received from the Govt. of NCT of Delhi, it has been decided by the Board that Result of SC/ST (Outsider) candidates will be processed as per applicable current policy on SC/ST based on order of Hon'ble High Court dated 12/09/2012 in WP(C) No. 5390/2010 titled as Deepak Kumar & Ors Vs. District & Session Judge, Delhi subject to fulfillment of other eligibility conditions as per advertisement & RRs as on cutoff date i.e.05/01/2010 & other directions received from Government or Courts.

The User Department shall also get the SC/ST/OBC/OH/VH certificates verified from the issuing authority before his/her appointment. Further, in case of the OBC candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-ESTt. (SCT) dated 08.09.1993 O.M. No. 36033/3/2004-ESTt. (Res) dated 09.03.2004 and O.M. No. 36033/3/2004-ESTt. (Res) dated 14.08.2008.



The Hon'ble High Court of Delhi vide judgement dated 06/02/2013 in WP(C) 3397/2012 titled as DSSSB V/s. Preeti Balyan ordered that the cut off date would be 15-01-2010 for the post code 70/09. Therefore, in compliance of the judgement of Hon'ble High Court of Delhi, the candidature of those candidates, who had not completed their eligibility criteria as on 15-01-2010, have been rejected. The result has been processed keeping in view of the eligibility conditions regarding educational qualifications/caste certificate/disability certificate etc. as on cut-off date i.e. 15-01-2010.

Further, the result of the following candidates have been kept pending due to requirements of various documents. These candidates are hereby directed to appear for verification and submission of documents at Board premises alongwith all relevant documents and copy of admit cards & 2 passport size photographs on 02/02/2016 at 11:00 am. to 4:00 pm. failing which No further opportunity will be given. This may be treated as last and final opportunity and thereafter the result of the post code shall be closed.


(1). Chinta Bai Meena, Roll No.07067650 may be read as ST category instead of SC category.


