### Supplementary Result Notice No.-806 Laboratory Assistant, Post Code-74/14 In Delhi Jal Board

- 1. DSSSB vide result notice No. 658 dated 01.06.2018 had provisionally selected 10 candidates (UR-06, OBC-02 & SC-02) to the post of Laboratory Assistant in Delhi Jal Board under **post code 74/14**.
- 2. User Department i.e. Delhi Jal Board has returned the dossier of Roll No. 12003888 in UR, 12003901 in UR, 12006314 in OBC, 12003768 in OBC & 12006002 in SC category, on 18.12.2018 after cancelling of the candidature on the ground that candidate has not responded/ joined the post of Laboratory Assistant. AS the validity of the waitlist panel is up to 31.05.2019 and the five dossiers have been received prior to the expiry of the waitlist panel, the Board is declaring the result of the candidates from the waitlist panel. The vacancy created on cancellation of candidature of candidate having roll number 12003888 in UR, 12003901 in UR, 12006314 in OBC, 12003768 in OBC & 12006002 in SC category has been processed from the waitlist candidate of UR, OBC & SC category.
- 3. On the basis of screening test held on 25.05.2014 and Interview held on 07.08.2014 & 08.08.2014 and on the marks scored by candidates in Academic qualification & Experience Assessment & Interview. After preliminary scrutiny of eligibility for the post as per provisions of statutory RRs and the terms & conditions of the advertisement the following candidates are provisionally selected to the post of Laboratory Assistant in Delhi Jal Board under post code 74/14.

The candidature of the above candidates have been nominated for selection purely as conditional, subject to the condition that user department shall offer the appointment letter to him only if the candidate fulfils the eligibility condition as per RRs of the post especially regarding the experience certificate furnished by the candidate.

5. The Selection of the above 05 candidates (02 UR, 02 OBC & 01 SC) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code.

The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

- 4. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency notices in the documents of the candidate at their own level.
- 5. It is stated that the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 6. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/08/2008.
- 7. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment.
- 8. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms *vis-à-vis* the original documents. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 9. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 10. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 11. The recruitment process for the post of Laboratory Assistant stands closed in all respect.

- 12. Further waitlist panel/panel for the post code 74/14 stands expired on 31.05.2019 i.e. after one year from the date of declaration of result on 01.06.2018.
- 13. The category-wise marks scored by the last candidate provisionally nominated are as under:-
