ASSISTANT SUPERINTENDENT IN DELHI PRISONS DEPARTMENT (POST CODE-38/13)

- 1. The DSSSB vide result notice No. 342 dated 15.10.2015 and subsequent result notice No. 350 dated 18.12.2015, result notice No. 367 dated 14.01.2016, result notice No. 415 dated 28.07.2016, result notice No. 511 dated 16.05.2017 and result notice No. 679 dated 30.06.2018 has effectively provisionally selected 19 candidates for the post of Assistant Superintendent in Delhi Prisons Department.
- 2. Candidature of candidate having roll number 13001601 was kept pending in EXSM/UR category for obtaining the requisite documents, however the candidate has failed to upload any document in e-dossier made active for him for 15 days wef 11.07.2018 and 25.07.2018, accordingly his candidature is hereby cancelled
- 3. Further candidature of candidate having roll number 13004118 was pending in EXSM/OBC category for obtaining the details of his EXSM service, the candidate has now provided the requisite document in his e-dossier.
- 4. Accordingly as per the merit list of the postcode 38/13 whose written examination was conducted on 09.03.2014, after qualifying the PET and after preliminary scrutiny of the candidature of candidate as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification & the terms and conditions of the advertisement, the following candidate is provisionally selected to the post of Assistant Superintendent subject to satisfaction in regard to any defect or deformity (including bow legged, knocked knees, flat feet etc.) which would render candidate ineligible for recruitment as per the requirement of the RRs:

- 6. Candidature of candidate having roll number 13007613 is still pending in SC category for receipt of details of declaration of result of Degree from the candidate.
- 7. In compliance of Ld CAT interim order dated 9.2.2017 in OA No 35/2017 in the matter of Kuldeep Kadyan vs DSSSB and interim order dated 9.1.2017 in OA No 4312/16 in the matter of Pawan vs DSSSB, one post each in UR category and SC category respectively are being kept vacant.
- 8. The selection of the above **01** Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. **Further the user department shall arrange for checking of defect or deformity (including bow legged, knocked knees, flat feet etc.) of the candidates as per the requirement of the RRs, which has not been done during PET-III.**
- 9. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 10. The User department shall check the eligibility of the reservation benefit and age relaxation of the candidate. Further User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 11. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Degree. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 12. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
