The DSSSB vide its result Notices Number 444 dated 17.10.2016 and 466 dated 13.01.2017 had declared the result of 28 candidates for the post of *Post Graduate Teacher (Economics) (Female)* in Directorate of Education under **Post code 131/2012**.

Candidature of candidate having roll number 28000352 was kept pending for seeking documents from the candidate vide result notice number 444 dated 17.10.2016. Despite the notices dated 24.11.2016, 5.7.2017 and 18.04.2018 the candidate has failed to furnish the requisite documents. Accordingly her candidature for the said post is hereby cancelled.

The selection of the above 01 Candidate shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or any other genuine reason.
