# GRADE IV (DASS) IN SERVICES DEPARTMENT UNDER POST CODE 61/2015

- 1. The DSSSB vide result notice number 690 dated 16.07.2018 has provisionally selected 895 candidates for the post of Grade IV (DASS) in the Services Department under Post code 61/2015 against the revised vacancies on the basis of the One Tier written examination held on 17.09.2017, and the Skill test of shortlisted candidates conducted wef from 03.01.2018 to 14.01.2018 and 08.04.2018 (for VH category candidates).
- 2. In the result notice dated 16.07.2018 candidature of 29 candidates were kept as pending for want of complete documents/clarification. After receipt of requisite documents and clarifications the pending result is hereby declared.
- 3. The Services Department vide their letter number F.14(5)/4/2016/Misc/S.III/2497 dated 28.08.2018 has clarified that 3 years Diploma after 10<sup>th</sup> may be considered for the post of Grade IV (DASS), accordingly the pending candidatures of affected candidates are processed accordingly.
- 4. The Services Department vide their letter number F. 14(5)/4/2016/Misc/S.III/2622 dated 18.09.2018 has clarified that age relaxation to sportsperson candidate may be considered as 8 years in the case of sportsperson belongs to OBC category for the post of Grade IV (DASS), accordingly the pending candidature of affected candidate is processed accordingly.
- 5. The Services Department vide their letter number F.14/6/2/2018/rectt/S.III/2256 dated 10.08.2018 has returned the dossier of Vikesh (15400430) who was selected under VH category with the remarks that the disability certificate of the candidate shows his disability as "Locomoter Disability" which is covered under OH category. In view of the same on re-examining the candidature of Sh. Vikesh (15400430) it has been observed that the candidate himself has applied under PH(Ortho) category under postcode 61/15, However

inadvertently he has been considered in VH category. Accordingly the selection of Sh. Vikesh (15400430) in under PH(VH) category in postcode 61/15 is hereby rescinded and his candidature is considered in PH(OH) category and is placed in WL (OH) category as per his merit.

6. In view of the additional documents furnished by the candidates whose candidature were pending and clarifications dated 28.08.2018 and 18.09.2018 of the user department, and after preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the <u>educational qualification</u> and the terms and conditions of the advertisement, the following candidates are provisionally selected to the of Grade IV (DASS) in the Services Department under Post code 61/2015.

- 24. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 25. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the 12<sup>th</sup> qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
