The OBC category candidates with certificate of Delhi Origin issued by the Competent Authority of Govt. of NCT of Delhi only have been considered for admissibility of benefit of reservation. The competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished by the candidates, in the application form through verification of the same from original documents. Mere inclusion of name in the result notice does not confer any right of the candidate over the post.
