RESULT NOTICE NO. 749 MATRON IN DELHI PRISONS DEPARTMENT (POST CODE-36/13)

- 1. The DSSSB vide its advertisement No. 02/2013 with closing date 02.08.2013 had advertised 81 vacancies (UR-41, OBC-22, SC-12, ST-06 out of which 08 vacancies were reserved for EXSM) for the post of Matron under postcode 36/13 in Delhi Prisons Department. The Board had conducted the written examination on 02.03.2014 for the post of Matron. After conducting the Physical Endurance test (PET-I) in respect of shortlisted candidates from 16.3.2015 to 22.3.2015, the final result was declared vide result notice number 343 dated 6.11.2015 and subsequent result notices number 366 dated 11.1.2016 and result notice number 383 dated 13.04.2016. Later additional candidates were shortlisted candidates to appear for PET-II to fill up the unfilled vacancies. PET-II was conducted on 14.07.2016, on qualifying the PET-II, the final result was declared vide result notice number 417 dated 29.7.16 and subsequent result notice number 479 dated 3.3.17.
- 2. Further vide notice number 534 dated 22.08.2017 additional 49 candidates were shortlisted for appearing in PET-III against the unfilled vacancies of the post. The PET-III was conducted on 16.02.2018 and its final result was declared vide result notice number 680 dated 30.06.2018. Simultaneously additional 51 candidates were shortlisted for appearing in PET-IV against the unfilled vacancies of the post. The PET-IV was conducted on 18.09.2018 and its result was declared vide result notice number 730 dated 26.10.2018. In the PET-IV only four candidates having roll number 13001492, 13001439, 13002484, 13003363 had qualified the PET. Accordingly the edossier of the said candidate was also called vide notice dated 26.10.2018 to upload their documents latest by 12.11.2018.
- 3. On receipt of the e-dossier and after preliminary scrutiny of the candidature of candidates as per the provisions of the statutory Recruitment Rules for the post in respect of the educational qualification and the terms and conditions of the advertisement on qualifying the PET, the following candidates are provisionally selected to the post of Matron subject to satisfaction in regard to any defect or deformity (including bow legged, knocked knees, flat feet etc.) which would render candidate ineligible for recruitment as per the requirement of the RRs:

- 5. The selection of the above **03** candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. Further the user department shall arrange for checking of defect or deformity (including bow legged, knocked knees, flat feet etc.) of the candidates as per the requirement of the RRs, which has not been done during PET-III.
- 6. The candidature of the candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 7. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 8. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the Degree. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 9. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 10. Further, selection of the following candidate who was earlier selected vide result notice number 417 dated 29.07.16 under UR category is now shifted to SC category
