ASSISTANT (OT/CSSD) IN HEALTH & FAMILY WELFARE DEPARTMENT UNDER POST CODE 35/2014

- 1. The DSSSB vide result notice No. 507 dated 09.05.2017 and result notice No. 718 dated 26.9.2018 had declared the results 14 candidates for the post of Assistant (OT/CSSD) in Health & Family Welfare Department under post code 35/14.
- 2. The candidature of candidate having Roll No 12005585 was kept pending in SC category for want of clarification from user department regarding admissibility of age relaxation to contractual employees working in medical institution of MCD.
- 3. The requisite clarification was sought from the User Department vide letter dated 10.1.2018 and its subsequent reminders dated 15.2.2018 and 23.3.2018. The user department was also requested for an early clarification vide COE DO letters 14.6.2018 and 31.10.2018. Further OSD to Chief Secretary was requested vide letter dated 14.8.2018 to take up the said issue in the HOD meeting. However no clarification on the subject was received from the user department regarding the admissibility of age relaxation to the employee working as contract employee in MCD alongwith the age relaxation as admissible for SC employees.
- 4. As per the provisions of RRs for the post of Assistant (OT/CSSD; letter dated 19.8.2011 of H&FW Department and corrigendum dated 27.2.2014 of DSSSB to the advertisement No. 01/2014 wherein it has been clarified that age relaxation for appearing in examinations for para medical posts is granted to contractual employees who have worked for more than three years on contract basis in Delhi Government hospitals/medical institutions for a period equivalent to the number of years they have worked on contract basis and also as per Department of Personnel & Training, Government of India OM No. 15012/2/2010-Estt.(D) dated the 27th March, 2012, the candidature of the candidate having roll number 12005585 is hereby rejected.
