# Junior Stenographer (English) In NDMC Under Postcode 47/2012

- 1. The DSSSB vide its advertisement No. 02/2012 with closing date 15.6.2012, had advertised 33 vacancies (16 UR, 17 OBC including 01 PH) for the post of Junior Stenographer (Eng) in NDMC under Post code 47/2012. Board conducted one tier written examination for selection to the post along with similar postcodes on 11.06.2017. Board had declared marks of Tier-I written examination of the candidates of the post of Junior Stenographer (Eng) in NDMC under Post code 47/2012 vide notice number 548 dated 06.10.2017.
- 2. Based on the performance in the one tier examination, 157 candidates were shortlisted for appearing in Shorthand and Typewriting Skill Test vide notice number 562 dated 25.10.2017. The skill test for shorthand and typewriting was conducted w.e.f. 08.02.2018 to 11.02.2018, wherein 110 candidates have appeared. The result of skill test was declared vide notice number 694 dated 23.7.2018.
- 3. The Board has adopted the criteria for evaluation of the skill test on the pattern of SSC and considered upto 7% mistakes in shorthand skill test for UR category and upto 10 % mistakes in shorthand skill test for all reserved category candidates, as qualified with a speed of 80 w.p.m. As per RRs for the post the candidate was to qualify the 30 w.p.m. in typewriting in English, aswell.
- 4. After preliminary scrutiny of the candidature of candidates on the basis of the documents uploaded by the them in their e-dossier as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of Junior Stenographer (Eng) in NDMC under Post code 47/2012 for consideration of the remarks mentioned against his name by the user department. **DSSSB** has however not undertaken any veracity/scrutiny of documents related to Knowledge of

- 15. The above selection is purely provisional as DSSSB has however not undertaken any veracity/scrutiny of documents related to Knowledge of Computer, therefore User Department must ensure the eligibility of the candidate in terms of the knowledge of computer as per the RRs at their own level.
- 16. The selection of the above 23 Candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 17. Candidature of candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate
- 18. The User department shall check the eligibility of the reservation benefit, if applicable. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.

- The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the matriculation or equivalent qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 20. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
