Stenographer Grade III In MAIDS under Postcode 152/2014

- 1. The DSSSB vide its advertisement No. 01/2014 with closing date 27.02.2014, had advertised 4 vacancies (3 UR, 01 OBC) for the post of Stenographer Grade III in MAIDS under Post code 152/2014. Vide addendum/corrigendum dated 25.07.2014, out of 04 vacancies for postcode 152/2014, 01 vacancy was reserved for PH(OH) category. Board conducted one tier written examination for selection to the post along with similar postcodes on 11.06.2017. Board had declared marks of one tier written examination of the candidates of the post of Stenographer Grade III in MAIDS under Post code 152/2014 vide notice number 549 dated 06.10.2017.
- 2. Based on the performance in the one tier examination, 48 candidates were shortlisted for appearing in Shorthand and Typewriting Skill Test vide notices number 563 dated 25.10.2017 and 588 dated 24.01.2018. The skill test for shorthand and typewriting was conducted w.e.f. 08.02.2018 to 11.02.2018, wherein 31 candidates have appeared. The result of skill test was declared vide notice number 695 dated 23.7.2018.
- 3. The Board has adopted the criteria for evaluation of the skill test on the pattern of SSC and considered upto 7% mistakes in shorthand skill test for UR category and upto 10 % mistakes in shorthand skill test for all reserved category candidates, as qualified with a speed of 80 w.p.m. As per RRs for the post the candidate was to qualify the 40 w.p.m. in typewriting in English on computer, aswell.
- 4. DSSSB has however undertaken preliminary scrutiny of documents as per the RRs for the post of Stenographer Grade III of the Services Department, as the user department has submitted that they have adopted the RRs as notified and amended by Govt. of NCT of Delhi from time to time

5. After preliminary scrutiny of the candidature of candidates on the basis of the documents uploaded by the them in their e-dossier as per the provisions of the statutory Recruitment Rules for the post of Stenographer Grade-III of Services Department and the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of Stenographer Grade III in MAIDS under Post code 152/2014 subject to consideration of the remarks mentioned against name by the user department.

Candidature of candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate
- 15. The User department shall check the eligibility of the reservation benefit, if applicable. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.
- 16. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the 12th pass or equivalent qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 17. In respect of the unfilled vacancies in UR category the DSSSB has proposed to further shortlist the additional candidates for phase-II of skill test.
- 18. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 19. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
