- 1. The DSSSB vide its result notice number 707 dated 25.08.2018 has provisionally selected 154 candidates for the post of Stenographer Grade III in Services Department under Post code 211/2014.

The 02 candidates having roll number **14317058** (Atul Saini) and **14317251** (Sonia), who were common candidates in postcode 47/12 & 211/14 and had given their first preference of postcode as 47/12, as such their provisional selection in postcode code 211/14 in UR category vide result notice number 707 dated 25.08.2018 is hereby **rescinded**. The Board had conducted the combined examination for post code they have now been selected in postcode 47/12, 152/14 and 211/14 as such the candidate is being selected in only one postcode as per their merit and preference of post.

- 6. Candidature of 01 candidate having roll number **14304695** is still pending in UR category for receipt of requisite clarification from user department regarding admissibility of the higher secondary certificate furnished by the candidate.
- 7. Candidature of 01 candidate having roll number **14304000** is still pending in SP category for receipt of requisite clarification from Sports Authority of India as to whether the Amateur Cricket Federation of India a recognized Federation at a National Level and whether the sports certificate issued by said federation can be considered for selection of candidate to civil posts under sportsperson category.
- 8. Candidature of **01** candidate having Roll number **14300188** is still pending in OH category for receipt of requisite clarification from the concerned Branch regarding the admissibility of the typewriting exemption as claimed by the candidate.
- 9. The selection of the above **02** candidates shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 10. Candidature of candidate is liable to be cancelled by the User Department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the post or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate
- 11. The User department shall check the eligibility of the reservation benefit, if any. Further, if applicable User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.

The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents including the 12<sup>th</sup> qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 13. In respect of the unfilled vacancies the DSSSB has already shortlisted the additional candidates for phase-II of skill test.
- 14. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
