POST GRADUATE TEACHER (HISTORY) (FEMALE) IN DIRECTORATE OF EDUCATION UNDER POST CODE 139/2012

- 1. The DSSSB vide result notice number 484 dated 15.03.2017; result notice number 518 dated 12.06.2017 and result notice number 573 dated 15.11.2017 had provisionally selected 57 candidates for the post of *Post Graduate Teacher (History) (Female)* in Directorate of Education under **Post code 139/2012**.
- 2. The candidature of the candidate Ms Keerti Dua (26004186) has been cancelled by the Directorate of Education (user department) vide order number F.No DE 2(8) (11) E-II/DR/PGT/History/17/2568 dated 22.11.2017 on account of not accepting the offer of appointment. In view of the same the candidature of the candidate kept in waitlist/panel in UR category is being considered against the vacancy created by Keerti Dua.
- 3. The representation dated 27.06.2016 filed by candidate namely Pinki Devi having Roll number 26004187 was examined by the Board and in view of the fact that the candidate has wrongly bubbled her roll number in OMR sheet, her Tier-II (Objective) examination OMR sheet has not been evaluated, accordingly Board has decided that her candidature shall be considered as rejected in postcode 139/12. An OBC vacancy which was kept as withheld on account of her representation is hereby released
- 4. The representation dated 16.03.2017 filed by the candidate namely Ms Asha having roll number 26003292 was examined wherein the candidate has stated that she had applied under postcode 139/12, however was not considered therein. In view of the fact that the candidate has manually applied the application form for the post of PGT (History) under postcode 139/12 having ID number 2082701 and in the light of Hon'ble High Court judgment dated 27.11.2015 in similar matter in WPC 9869/2015, CM No 23868/2015 in the matter of Vikas Chaudhary vs GNCTD, the candidature of Ms Asha (26003292) is considered in postcode 139/12. However the candidature of Asha (26003292) is rejected as the candidate is not qualified on cut off date; as per the documents provided by the applicant, the 2nd

year result of MA degree declared on 28.9.2012 whereas the cut off date is 15.06.2012.

- 5. The candidature of Sucheta Arora (26004409) is rejected as the candidate is not qualified on cut off date; as per the documents provided by the applicant. Further, the candidate has not responded to Board notices dated 5/07/2017 and 16/04/2018 for submission of additional documents in respect of her MA qualification.
- 6. In view of above and on the basis of the merit list of Tier- II examination for the post held on 28.06.2015 and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules for the post & the terms and conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (*History*) Female under **Post code 139/2012**:

- 9. The candidature of candidate having roll number 26002788 (Suman) is pending in OBC category for obtaining documents through online mode.
- 10. The selection of the above 02 candidates shall be further subject to thorough verification of the candidature of the candidate by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 11. The User department shall also check the eligibility of the reservation benefit and verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms vis-à-vis the original documents.
- 12. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/ certificates before finally appointing the candidate. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered

necessary that the candidate is suitable in all respect for appointment to the post.

- 13. In view of interim order dated 9.9.16, in the matter of Vinit Kumar Singh Vs GNCTD in OA no100/3075/2016, MA 2721/16, MA 2722/16, the above selection is further subject to outcome of the said case and also to the outcome to OA No 100/3701/2016 in the matter of Naveen Prakash Vs DSSSB and OA No 3007/2016 in the matter of Sukhveer Singh Nayar Vs DSSSB.
- 14. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 15. This issues with the prior approval of the Competent Authority.
