In view of selection of the candidate Ms Neeraj Rani (26004271) in postcode 172/2014 and the pending court case in the matter of in the matter of Sangeeta Yadav vs GNCTD having OA 2215/2015 in Ld CAT, the candidature of last selected candidate in OBC Category (Aastha Dabas having Roll number 26002618) was withheld till the disposal of court matter of Sangeeta Yadav vide result notice number 520 dated 12.06.2017.

Ld CAT vide their order dated 22.01.2018 has disposed off the court case as the applicant Sangeeta Yadav was not in the zone of consideration, in view of the same the withheld selection of Aastha Dabas having Roll number 26002618 who was selected vide result notice number 486 dated 15.03.2017 under OBC category is hereby released.
4. The candidates having roll number 26003115 and 26003498 did not provide requisite documents inspite of notices dated 05.07.2017 and 16.04.2018 as such their candidature is hereby cancelled.
