The DSSSB vide its advertisement no. 01/2015 with closing date 26/11/2015 had advertised 20 vacancies (UR-15, OBC-03, ST-02 including 07 EXSM) for the Post of Matron under post code 63/15 in Delhi Prison Department. The Board had conducted Physical Endurance Test (PET) for the applicants of the post code from 19/11/2018 to 30/11/2018 (except Sunday) at Sports Complex, East Vinod Nagar (Mayur Vihar Phase-II), Near Neelam Mata Mandir, Delhi-110091.

On qualifying PET, 158 candidates were provisionally allowed to appear for written examination for post code 63/15, subject to correctness of the information furnished by the candidates in their online application forms.

The online examination was held on 29/03/2019. The marks statement of the above Post/Post Code has been uploaded on the Board's website for information of the candidates. Candidates can view their marks by logging into their account in OARS module on [www.dssbsonline.nic.in](http://www.dssbsonline.nic.in).

The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Certificates and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.

The category wise cut off marks for uploading e-dossier have been given as under:-

Category	UR	OBC	ST	EXSM
Cut Off marks	87	71.25	65.25	NA

The link for up-loading e-dossier shall be kept open for a period of 15 days w.e.f. 25/07/2019 to 08/08/2019. The candidates uploading e-dossier should ensure that she fulfills all the eligibility criteria as on the cutoff date, i.e., 26/11/2015. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number and e-mail ID. If any candidates fails to upload the e-dossier during the above said period, her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever grounds.

Mere asking the candidate for up-loading documents in the e-dossier module dos not confer her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload her documents on or before the date as mentioned above she will not be given any further opportunity and his/her candidature will be treated as cancelled.

While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
