Supplementary Result Notice No.- 832 Motor Vehicle Inspector, Post Code-64/15 In Transport Department

- 1. DSSSB vide result notice No. 663 dated 01.06.2018 and 684 dated 10.07.2018 had provisionally selected 11 candidates (UR-06, OBC-03 & SC-02) to the post of Motor Vehicle Inspector in Transport Department under **post code 64/15**.
- 2. User Department i.e. Transport Department has returned the dossier of candidate having Roll No. 12300098 in UR category, after cancelling of the candidature on the ground that candidate has not responded/ joined the post of Motor Vehicle Inspector. As the validity of the waitlist panel is up to 31.05.2019 and the one dossier has been received prior to the expiry of the waitlist panel, the Board is declaring the result of the candidates from the waitlist panel. The vacancy created on cancellation of candidature of candidate having roll number 12300098 in UR, has been processed from the waitlist candidate of UR.
- 3. On the basis of Tier-I examination held on 05.03.2017 and Tier-II examination held on 11.06.2017 and on the marks scored by candidates and after preliminary scrutiny of eligibility for the post as per provisions of statutory RRs and the terms & conditions of the advertisement the following candidate is provisionally selected to the post of Motor Vehicle Inspector in Transport Department under post code 64/15. Further, DSSSB has however not undertaken any veracity/scrutiny of the experience certificate being technical in nature, therefore user department must ensure the eligibility of the candidate in terms of the 05 years in a reputed automobile workshop which undertakes repairs of both light motor vehicle, heavy motor vehicle, heavy goods and passenger vehicles fitted with petrol and diesel engine as per the RR's and correctness of the experience certificate furnished by the candidates at their own level.

The candidature of the above candidates have been nominated for selection purely as conditional, subject to the condition that user department shall offer the appointment letter to him only if the candidate fulfils the eligibility condition as per RRs of the post especially regarding the experience certificate furnished by the candidate.

5. The Selection of the above 01 candidate (UR-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

- 6. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency notices in the documents of the candidate at their own level.
- 7. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms *vis-à-vis* the original documents. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
- 8. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 9. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 10. The recruitment process for the post of Motor Vehicle Inspector stands closed in all respect.
- 11. Further waitlist panel/panel for the post code 64/15 stands expired on 31.05.2019 i.e. after one year from the date of declaration of result on 01.06.2018.
