## NOTICE NO. 876 ASSISTANT DIRECTOR (PRESS AND INFORMATION) (POST CODE 49/13) IN MUNICIPAL CORPORATION OF DELHI

- 1. The DSSSB vide its Advertisement No. 03/13 with closing date 18/10/2013 had advertised 02 vacancies (UR-02) for the post of Assistant Director ( Press and Information) in Municipal Corporation of Delhi under Post Code 49/13. Board Conducted Tier-I written examination for recruitment in respect of this post on 24/09/2019.
- 2. The marks obtained by **81** candidates who have duly appeared in written examination (online mode in single shifts) held on **24/09/2019** have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dsssbonline.nic.in
- 3. Based on the performance in Tier-I written examination (online mode), out of these 81 candidates, all 12 (Twelve) candidates (UR-12) as detailed below, who obtained marks above or equal to qualifying marks have been provisionally shortlisted to appear in Tier-II examination which stands in the ratio of 1:6 subject to correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier II examination separately.

- 4. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier II examination does not entitled them any right over the post.
- 5. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies.
- 6. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in Two Tier written examinations for UR Category Candidate is 40% and for EXSM category candidate, there is 5% relaxation.
- 7. All qualified candidates for appearing in Tier II examination have been called which stands in the ratio of 1:6 of the advertised vacancies.
- 8. The details of Tier II examination shall be notified separately by the Board. The candidates are hereby advised to check the website of the Board regularly.
