1. The DSSSB vide its Advertisement No. 03/13 with closing date 18/10/2013 had advertised 05 vacancies (UR-03, OBC-01, ST-01 including PH (OH)-01) for the post of Assistant Director (Community Service) in Municipal Corporation of Delhi under Post Code 48/13. Board Conducted Tier-I written examination for recruitment in respect of this post on 19/09/2019.
2. The marks obtained by 152 candidates who have duly appeared in written examination (online mode in single shifts) held on 19/09/2019 have been uploaded on Board's website. Candidate can view their marks by logging into their account in the OARS Module www.dsssonline.nic.in
3. Based on the performance in Tier-I written examination (online mode), out of these 152 candidates, all 28 (Twenty Eight) candidates (UR-24, OBC-02 and ST-02) as detailed below, who obtained marks above or equal to qualifying marks have been provisionally shortlisted to appear in Tier-II examination subject to correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier II examination separately.

4. Only those candidates have been considered in OBC Category who have declared that they are OBC (Delhi) in their online application form
5. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier II examination does not entitle them any right over the post.
6. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
7. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in Two Tier written examinations for UR Category Candidate is 40%, for OBC Candidate is 35% for ST/PH candidate is 30% and for EXSM category candidate is 5% relaxation in their respective categories subject to a minimum of 30%.

8. All qualified candidates in Tier I examination have been called for appearing in Tier II examination.
9. The details of Tier II examination shall be notified separately by the Board. The candidates are hereby advised to check the website of the Board regularly.
