ASSISTANT TEACHER (PRIMARY)
IN DIRECTORATE OF EDUCATION, GNCTD
UNDER POST CODE- 89/17

Attention is drawn to the Notice No 772 dated 20.03.2019 vide which the marks of 71,912 candidates were declared who appeared for the computer based test /examination held on 06 & 07 Oct 2018 and 10,11,14, & 29 Nov 2018 for the post of Assistant Teacher (Primary) in Directorate of Education, GNCTD, Post Code- 89/17. Attention is also drawn to the Result Notices Nos. 777 dated 22.05.2019, 790 dated 14.08.2019 and 806 dated 09.09.2019 vide which results were declared for the post of Assistant Teacher (Primary) in Directorate of Education, GNCTD, Post Code- 89/17.

2. However, subsequently, on analysis of documents/data collected i.e. Biometric Data and Photograph Captured before and after completion of exam etc. at the time of conduct of examination for Post Code-89/17 -Asst. Teacher (Primary) by DSSSB, it has been found that Ms. Aparna whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code exam:-

3. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:-

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:

- To be disqualified by the Board from the examination for which he/ she is a candidate as also from any other examination/ selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or*
- To be debarred either permanently or for a specified period from any examination held or selection made by them and or,*
- To take disciplinary action if he/she is already in service under Government and or,*
- To take any other legal action"*

4. Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post Codes in online, offline & PET examination:-

"If any case of impersonation comes to notice then Overall In-charge & Observer shall lodge FIR against both persons i.e. candidates who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/ Commissions."

5. Thus, it is clear that the candidate had arranged to have another person taking examinations in place of her. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
- ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v) Providing admit card to another person to enable him to appear on behalf of the candidate.

6. Further, the candidate has also indulged in the act of **FORGERY** by altering the identity proof of candidate, admit card etc, and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

7. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

8. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidate.

9. The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view of the above facts and circumstances, **the candidature of Ms Aparna D/W/o Ajit Kumar Rana, R/o H.No 115, Bazar Pana, Karala, Delhi having Date of Birth : 30/01/1992 bearing Roll No. : 111708901666 of Post Code 89/17 is hereby cancelled and the provisional selection made vide Result Notice No. 777 dated 22.05.2019 of Ms. Aparna D/W/o Ajit Kumar Rana having Date of Birth : 30/01/1992 bearing Roll No. : 111708901666 of Post Code 89/17 is hereby rescinded.**

This issues with the prior approval of the Competent Authority.
