NOTICE NO.: 934 ASSISTANT TEACHER (PRIMARY) IN DIRECTORATE OF EDUCATION, GNCTD UNDER POST CODE- 89/17

Attention is drawn to the Notice No 772 dated 20.03.2019 vide which the marks of 71,912 candidates were declared who appeared for the computer based test /examination held on 06 & 07 Oct 2018 and 10,11,14, & 29 Nov 2018 for the post of Assistant Teacher (Primary) in Directorate of Education, GNCTD, Post Code- 89/17. Attention is also drawn to the Result Notices Nos. 777 dated 22.05.2019, 790 dated 14.08.2019 and 806 dated 09.09.2019 vide which results were declared for the post of Assistant Teacher (Primary) in Directorate of Education, GNCTD, Post Code- 89/17.

2. However, subsequently, on analysis of documents/data collected i.e. Biometric Data and Photograph Captured before and after completion of exam etc. at the time of conduct of examination for Post Code-89/17 -Asst. Teacher (Primary) by DSSSB, it has been found that Ms. Indu whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code exam:-

- 3. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that she will be liable:
 - a) To be disqualified by the Board from the examination for which he/ she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
 - b) To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
 - c) To take disciplinary action if he/she is already in service under Government and or,
 - d) To take any other legal action".
- 4. Further, attention is drawn to the following declaration made by the candidate at the time of applying for the above post code i.e. 89/17, Assistant Teacher (Primary):

- "a) I hereby certify that all statements made in this application are true, complete and correct to the best of my knowledge and belief and have been filled by me.
- b) I also declare that I have submitted only one application for one post code in response to the advertisement.
- c) I have read all the provisions mention in the advertisement/notice of examination carefully as published in the website of DSSSB and I hereby undertake to abide by them.
- I understand that in the event of information being found false or incorrect at any stage prescribed in the notice or any ineligibility being detected before or after the examination, my candidature/selection/appointment is liable to be cancelled/terminated automatically without any notice to me and action can be taken against me by the DSSSB.
- e) the information submitted herein shall be treated as final in respect of my candidature for the post applied for through this application form.
- f) I also declare that I have inform my Head of Office/Department in writing that I am applying for this post/examination (For Government Employees only)".

- 5. Thus, it is clear that the candidate had hidden the facts while applying for the above post code application she has given false declaration i.e. "I also declare that I have submitted only one application for one post code in response to the advertisement".
- 6. Further, Ms Indu had not only filed two applications vide Application Nos. 61256232 & 39092212 Registration Nos. 1608199822126418332013 & 16081998022126418332013 for the same post code 89/17 and thus were got issued Roll Nos. i) 120108915041 and ii) 120108928678 respectively but also appeared in the exam conducted by DSSSB against both the Roll Nos as per details given in the above table.
- 7. The two forms were filed with malafide intention to appear twice in the same post code examination which is against the norms of the Board. She has thus violated the policy of equal level playing field viz-a-viz rest of the candidates appearing in the same exam.
- 8. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of misrepresentation of facts, false declaration, suppression of facts, incorrect facts and appearing twice in the same post code exam is made out against the candidate.
- 9. The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view of the above facts and circumstances, **the candidature of Ms. Indu D/W/o Jasbir Singh R/o VPO Dikadla**, Tehsil Samlkha, Distt Panipat, Haryana, having Date of Birth: 16.08.1998 bearing Roll Nos.: 120108915041 and 120108928678 of Post Code 89/17 is hereby cancelled.
