Based on the performance in examination, 17 candidates, as detailed below, have been provisionally allowed to upload e-dossiers in the ratio of 1:2 ratio (1: 3 where the number of vacancy is 01) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

5. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST upload their applicable documents in the said link.


6. The e-dossier link shall be active from 6.11.2017 to 21.11.2017.

9. This issues with the prior approval of the Competent Authority.


