While supplying the photocopy of evaluated answer sheet to the candidate under RTI, when the fact about posting/totaling error in marks came into notice, her merit has been revised as 997a with revised mark 107 and selected.

Pending result in respect of candidate Sh. Lalit Kumar Yadav, Roll No. 1620359 (Merit-410) is hereby cancelled, as on scrutiny of dossier of the candidate, it is revealed that the candidate had joined the two years ETE Diploma course of MP education Board without passing the qualifying/essential Senior Secondary School Exam.. Result of ETE First year was declared by the MP Education Board on 27.09.2006 whereas the Sr. Secondary School Exam. was passed by the candidate on 09.06.2006. Result in respect of two more candidates (1) Ms. Seema Rani, Roll No. 1611490(OBC-17) and (2) Ms. Seema Gulia Roll No. 1629466(OBC 209) erroneously included in result notice dated 06.10.2009 is rescinded on the ground that application forms for the post code were filed by these candidates after the prescribed date of receipt of application which was 12.08.2008. In term of the instructions of the advertisement No. 02/08 inviting application, their application form being invalid, disqualify them from the selection process. One of the candidate namely Ms. Seema Rani, even had not deposited the application fee.

Result in respect of remaining vacancies shall be declared in due course. In respect of candidates whose dossiers are wanting certain informations or whose candidature need verification etc., letters to the candidates have already been sent for removing the deficiencies etc..

For admissibility of benefit of reservation the result has been processed as per the judgment of Hon’ble Supreme Court of India dated 04.08.2009 as passed in passed in Civil Appeal No. 5092 of 2009 arising out of Petition (s) for Special Leave to Appeal (Civil) No(s). 24327/05 Subhash Chandra & Anr. V/s DSSSB & ors..

The selection of the above 52 candidates (UR-30, OBC-17, PH- 04 & VH 01) shall further be subject to verification of eligibility, as prescribed by the statutory RRs, verification of original documents and also the correctness of information as furnished by them in the application forms, by the competent authority of the user Department. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post. Selection/appointment of above candidates shall also be subject to the decision in pending court cases. In respect of 32 candidates against whom roll number * has been posted shall further be subject to verification of their identity for which the copy of OMR answer sheet containing declaration written and signed by these candidates on the day of examination are enclosed with the respective dossier to facilitate the user Department to verify their identities before issuance of offer of appointments.

While every care has been taken in preparing the result, DSSSB reserve the right to rectify errors and omission if any.
