This is in pursuance of directions of Hon'ble CAT vide order dated 7 March 2014 in OA No. 697/2013 titled Rajeev Kumar V/s GNCTD where in the operative paras 5 & 6 have been reproduced under:-

"5. From the above discussion, it will be clear that the judgment of the Honble Supreme Court in Pushpa (Supra) holds the field. Therefore, the Government of NCT of Delhi has to consider the applicant's candidature as an sc candidate and since he has obtained 98 marks, he cannot be denied appointment to the post of PGT (English). It appears from the Result Notice dated 17.08.2012 that out of four posts, only three recruitments have been made, therefore, one post should be still vacant. However, the respondents could not say with any amount of certainty that a vacant post is available. Even if the vacancy is not available, the respondents would have to appoint the applicant after preparing a fresh merit list of SC candidates and the one with the lowest marks would have to be reverted".

"6. In view of the above discussion, we direct the respondents to declare the applicant as selected for the post of PGT (English) and appoint him with effect from the date Shri Anil Kumar has been appointed, maintaining the applicant's seniority as a PGT, within a period of two months from the date of communication of a copy of this order. No costs".

The brief facts of the case are that the result of post code 21/10 was declared vide result notice no. 287 dated 17.08.2012 and result notice no. 304 dated 01.02.2013. The candidature of the applicant Sh. Rajeev Kumar was rejected as he was SC (Migrant) as per the Subhash Chandra Judgment mentioned in the advertisement. However, the Hon'ble CAT in OA No. 697/2013 directed to appoint the applicant after preparing a fresh merit list of SC candidates and the one with the lowest marks would have to be reverted.

Now, in compliance of above mentioned order of Hon'ble CAT, Sh. Rajeev Kumar is hereby provisionally selected for the post of PGT (English) (Male) post code 21/10 under SC category as per detailed below:-
