(ii) OBC certificate dated 12.08.2015 issued on the basis of her earlier OBC certificate No. 90509079146522 dated 19.11.2014.
		Accordingly, the candidate is requested to upload OBC (Delhi) certificate as on cutoff date by which the candidate is recognized as a backward class under the Govt. of NCT of Delhi.

- 2. The above candidates are being given 2<sup>nd</sup> and final opportunity to upload the deficient documents in the e-dossier w.e.f. 11.03.2021 to 15.03.2021.
