ORDER

Whereas, the DSSSB had advertised an advertisement for 200 (UR-82, OBC-62, SC-37, ST-19 including, PH(OH-OA/OL/OAL/BL)-02, PH (VH-04, EXCM-27) post of Teacher Primary (Urdu) in MCD, Post Code No. 69/09 with closing date for receipt of application form 15/01/2010. The DSSSB had conducted examination on 28/04/2013 for the selection of said post.

Whereas the Board has declared first Result vide Office Order No. 322 dated 01/03/2014 declaring 82 candidates passed and second Result vide Office Order No. 327 dated 08/05/2014 declaring 38 candidate pass. The Board also issued Rejection Notice vide Office Order No. 323 dated 01/03/2014 and Rejection Notice vide Office Order No. 328 dated 08/05/2014 with reason for rejection of candidatures of candidates in Remarks column.

Whereas, the candidature of Sh. Md. Tariq under OBC category having marks 78.25 had been rejected due to reason "OVERAGE". The applicant filed an appeal in Hon'ble CAT vide OA no. 1098/2014 in which the applicant stated that he should be given age relaxation as he was working in MCD as contractual teacher. The Hon'ble Cat has disposed off the OA with the following order which is reproduced as under:-

"3. to the facts and circumstances stated in the OA, the O.A. is disposed of with the direction to having regard respondent No. 1 to take steps to decide the representation of the applicant preferred on 03rd March 2014 within a period of three weeks from the date of receipt of a copy of this order and communicate the same to the applicants by passing a speaking order. No costs."

Whereas, in compliance of the judgment of Hon'ble CAT dated 05/05/2014, the case of Sh. Md. Tariq was again taken up and it is observed that MCD has provided vide letter no. A/ADE/TRC/Edu./HQ/2011/1476 dated 25/11/2011 a list of 347 contract teachers, who have worked in MCD, for the benefit of age relaxation in Post Code 69/09. On scrutiny of said list, the name of applicant Sh. Md. Tariq has not appeared in the list and therefore he is not entitled to the age benefits. According to date of Birth of applicant (i.e.

30/12/1979), he became Overage in OBC category. Hence the candidature of Sh. Md. Tariq was rejected.

Therefore, in view of the above facts, Sh. Md. Tariq could not be considered for selection to the post of Teacher Primary (Urdu) MCD, Post Code 69/09.

This issues with the prior approval of Competent Authority.
