## <u>ORDER</u>

This order shall dispose of the representation dated 15.06.2021 filed by Ms. Chetna Shokeen (Roll No. 12321500771), candidate for the post of Assistant Teacher (Nursery), Post Code-16/19.

- 2. The candidate Ms. Chetna Shokeen (Roll No. 12321500771) applied for the post of Assistant Teacher (Nursery) under Post Code-16/19 under OBC category and appeared in the computer based online examination on 19.11.2019 and scored 92.00 marks out of 200 marks. The Candidate was shortlisted for uploading of all the relevant documents in the edossier with regard to Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module w.e.f. 30.06.2020 to 14.07.2020 (15 days) vide Notice No. F. No. 236/Result/Asstt. Teacher(Nursery)/Int. Cell/DSSSB/2019-20/1636-44 dated 22/06/2020 on the Board's website i.e. www.dsssb.delhi.gov.in.
- 3. That on scrutiny of the documents uploaded in the e-dossier by Ms. Chetna Shokeen (Roll No. 12321500771), it has been found that the candidate has not uploaded (i) "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" & (ii) OBC (Delhi) certificate. As the candidate has mentioned in OARS application form that she has done B.Ed. (Nursery) from MDU in July, 2019 with 67% marks, she was given 10 days first opportunity w.e.f. 25.11.2020 to 04.12.2020 to upload "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" & OBC (Delhi) certificate in the e-dossier but she failed to upload the same.
- 4. That even after giving 10 days 1<sup>st</sup> opportunity w.e.f. 25.11.2020 to 04.12.2020, it was found that Ms. Chetna Shokeen failed to upload the B.Ed. (Nursery) from MDU in July, 2019in the e-dossier. Accordingly, she was given 05 days, 2<sup>nd</sup> and final opportunity w.e.f. 22.03.2021 to 26.03.2021 to upload (i) "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" & (ii) OBC (Delhi) certificate vide Notice No. F. No. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/DSSSB/2019-20/708-716 dated 17/03/2021.

- That the candidate Ms. Chetna Shokeen (Roll No. 12321500771) has submitted representation dated 15.06.2021 stating that "I have not received any mail or communication from your office. Also me and my family were corona positive, even after trying hard, I was unable to upload the documents. Also I don't have computer at my place and it becomes a problem as I have to go to the café and the persons a the café has less knowledge regarding these things in my locality Hence, I was not able to upload the documents and lost the chance".
- 8. That the representation dated 15.06.2021 of the candidate has been examined in detailed and it is clear that as per policy of the Board, the candidate Ms. Chetna Shokeen (Roll No. 12321500771) has failed to upload the (i) "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" & (ii) OBC (Delhi) certificate even after giving two sufficient opportunities w.e.f. 25.11.2020 to 04.12.2020 (10 days) & 22.03.2021 to 26.03.2021 (05 days). Also the candidate has merely made excuses and has not uploaded any documents etc in support of her claim. Further, the applicant had failed to upload the essential qualification of RRs. Hence, her candidature has been rejected for not having "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute". Further, as the merit of UR category became lower and her candidature came in the zone of consideration under UR category, hence, OBC (Delhi) certificate was not required at present scenario.
- 9. Further, the Hon'ble High Court vide order dated 22.04.2019 in W.P. (C) No. 4085/2019 in the matter of Jyoti Vs. Govt. of NCT of Delhi and Anr. & vide order dated 25.03.2019 in W.P. (C) No. 2892/2019 in the matter of Pushpender Singh Pranami Vs. DSSSB has upheld the policy decision of the Board to get online e-dossier only.
- 10. In view of the above, the above referred representations in r/o of Chetna Shokeen (Roll No. 12321500771) has been considered and examined in details and accordingly dismissed as the reason for rejection of her candidature for the post of Assistant Teacher (Nursery), Post Code-16/19 is justified because though she can be considered under UR category on merit but she failed to upload two years diploma in Nursery Teacher Training or B.Ed. (Nursery) from a recognized Institute. Her justification given in representation is not tenable as other candidates filled their complete e-dossier in all respect during the same time period.
- 11. This issues with the approval of Competent Authority, DSSSB.
