## NOTICE NO. 1327 ASSISTANT SUPERINTENDENT IN DELHI PRISON DEPARTMENT UNDER POST CODE 38/2013

- 1. That DSSSB issued an advertisement No. 02/2013 for the vacancies for the post of Assistant Superintendent (Jail) (Post Code 38/13) in Delhi Prison Department.
- 2. That Sh. Pawan (Roll No. 3813007112) herein applied for the post of Assistant Superintendent, under Post Code 38/13) in Delhi Prison Department and appeared in Written exam on 09.03.2014.
- 3. Sh. Pawan (Roll No. 3813007112) could not appear in Physical Endurance Test (PET) on scheduled date as the intimation of PET was not timely sent to him and subsequently filed OA No. 4312 of 2016 seeking selection to the post of Assistant Superintendent in Prison Department.
- 4. That the Ld. Tribunal vide impugned order dated 20.01.2021 allowed the OA filed by Sh. Pawan. The DSSSB filed W.P.(C) 6611/2021 & CM NO. 20763-64/2021, GNCT of Delhi Vs Sh. Pawan, but the Hon'ble High court dismissed the Writ vide its order dated 16.07.2021.
- 5. DSSSB in compliance of order dated 20.01.2021 of Ld. Tribunal and order dated 16.07.2021 of Hon'ble High Court of Delhi, conducted a PET for Sh. Pawan on 02.12.2021.
- 6. On the basis of marks obtained in written examination and on the basis of performance in PET candidate having roll number 3813007112, is provisionally allowed to upload e-dossiers subject to correctness of the information furnished by the candidates in his application form.



- 7. The result status of the candidate is being uploaded in OARS module. Candidate can check his status by logging into his account in OARS module on www.dsssbonline.nic.in.
- 8. The candidate MUST upload his all requisite/applicable documents in the said link.
- 9. The e-dossier link shall be open for 15 days with effect from 15/12/2021 to 29/12/2021. The candidate uploading e-dossier should ensure that he fulfills all the eligibility criteria as on the cutoff date i.e. 02/08/2013. The shortlisted candidate is also being separately informed through SMS & E-Mail on his registered mobile number and email ID as an additional facility. If candidate fails to upload the e-dossier during the above said period, his candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever grounds.
- 10. Mere asking the candidate for up-loading documents in the e-dossier module does not confer his any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned above he will not be given any further opportunity and his candidature will be treated as cancelled.
- 11. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
- 12. In case of non-compliance of the above instructions regarding uploading the edossier, the candidature of the candidate is liable to be cancelled/rejected.
- 13. This issues with the prior approval of the Competent Authority.
