## **CORRIGNEDUM No. 1130**

## TGT (ENGLISH), FEMALE (POST CODE 02/2010) IN DIRETORATE OF EDUCATION, GNCTD

- The DSSSB vide its advertisement number 01/2010, had advertised 343 vacancies (UR-247, OBC-35, SC-61including VH-0, HH-01) for the Post of TGT (English), Female (Post Code 02/2010) in Directorate of Education
- 2. DSSSB vide its Result Notices No. 138 dated 11.03.2011, No. 145 dated 28.06.2011, No. 147 dated 01.07.2011, 152 dated 27.09.2011, 161 dated 03..022012, 163 dated 17.02.2012, 177 dated 04.05.2012, 189, dated 02.07.2012, 197 dated 28.08.2012, 239 datd 18.02.2014, 387 dated 10.05.2016 and 580 dated 29.11.2017 had declared result of 311 candidates including 246 candidates in UR category for the Post of TGT (English), Female (Post Code 02/2010) in Directorate of Education.
- 3. At the time of declaration of result, candidature of Ms. Archna Agarwal having Roll No. 216857, who had scored 126 marks, was rejected on the ground that she had not studied English paper all three years of graduation. Hon'ble High Court of Delhi vide its judgment dated 11.05.2016 in WPC 10300/2015 in the matter of Archna Agarwal Vs Govt. of NCT of Delhi & Ors. in light of their earlier judgment dated 07.08.2013 in the matter of Sachin Gupta had found the applicant eligible for the Post.
- 4. In view of Hon'ble High Court order dated 11.05.2016 in WPC 10300/2015 in the matter of Archna Agarwal Vs GNCTD & Ors., whereby it was directed to consider the candidature of Archna Agarwal (Roll No. 216857) for the post and the fact that all the UR vacancies for the post have already been filled and also the fact that Archna Agarwal had more marks as compared to the last selected candidate in UR category in the Post Code 02/2010, accordingly nomination Ms. Rajni Lamba(Roll No. 214820), who was the last selected candidate having 93 marks and was selected vide Result Notice No. 163 dated 17.02.2012 in compliance of Ld. CAT order dated 13.01.2012 in OA No. 3723/2011 in the matter of Rajni Lamba Vs DSSSB & Ors. against the vacant post of TGT (English) in UR category, was rescinded vide Result Notice No. 580 dated

29.11.2017. Further, the candidate Ms. Archna Agarwal (Roll No. 216857) selected vide the said Result Notice No. 580 dated 29.11.2017 under UR category in the Post code 02/2010.

- 5. Now, User Department i.e. Directorate of Education vide letter No. DE/3(51)/E.III/DR/2011/PF/Vol.I/2055-56, dated 07.04.2021, enclosing therewith judgment of Hon'ble High court dated 25.03.2021 in WPC No. 3156/2021 titled as Govt. of NCT of Delhi Vs Rajni Lamba, requested to nominate Ms. Archna Agarwal (Roll No. 216857), without rescinding the candidature of Ms. Rajni Lamba (214820).
- 6. In view of request of the User Department, the order of rescinding of candidature of candidate Ms. Rajni Lamba (roll No. 214820) vide Result Notice No. 580 dated 29.11.2017, is hereby withdrawn. However, selection of candidate Ms. Rajni Lamba (Roll No. 214820) will be in access of notified vacancies in UR category under Post Code 02/2010, this aspect will be taken care by the User Department i.e. the Directorate of Education.
- 7. The rest of content of the Result Notice No. 580 dated 29.11.2017 shall be remained same.
