RESULT NOTICE NO- 279 WELFARE OFFICER (POST CODE-049/07) DEPARTMENT OF SOCIAL WELFARE, GNCTD

In compliance of order's of Hon'ble High Court of Delhi dated 23.07.2014 as passed in in W.P.(C) No. 814/2014, C.M. No. 1633/2014 case titled DSSSB V/s Tapan Neeraj and Ors. , The Hon'ble High Court of Delhi while disposing the said WP(C) has ordered that:-

"There cannot be any doubt about the binding nature of the declaration of law in the Supreme Court's judgment, especially in the National Federation of the Blind (supra). Consequently, if indeed there were certain vacancies that had to be earmarked for persons with disabilities in terms of the Disabilities Act, to be filled by them, that mandate had to necessarily be fulfilled. That a particular agency did not identify a post in a given recruitment year, even though vacancies existed, or one or the other State agency failed to notify it in the advertisement, cannot defeat the rights which otherwise exists. In the context of the present case, we notice that the recruiting department, i.e. the Department of social Welfare, in its counter affidavit filed before the CAT, had categorically stated that there were vacant posts of Welfare Office Grade-II in the Department and that even otherwise, at the stage of selection and initiation of recruitment process, the advertisement had clearly indicated that the vacancies specified were provisional and subject to change. Considering all these aspects, and the further circumstance that the GNCTD is not before this Court complaining that the directions of the CAT had in any manner adversely impacted its functioning, we are of the opinion that the writ petition at the behest of the DSSSB lack in merit, it is accordingly dismissed".

As per counter affidavit filed by Department of Social Welfare before the CAT, then had categorically stated that there were vacant post of Welfare Office Grade-II in the department and even otherwise, at the stage of selection and initiation of recruitment process, the advertisement had clearly indicated that the vacancies specified were provisional and subject to change.

Accordingly, the candidate with the following particulars has been provisionally selected to the post of Welfare Officer under post code 49/07 in the Department of Social Welfare, Govt. of NCT of Delhi in the Department and even otherwise in the pay scale of Rs 5500-9000 (Prerevised) as per particulars below:-

The competent authority of the User Department shall arrange to verify the correctness of information/documents as furnished in the application form by the candidate after verification of the same from original documents. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
