- 3. Further, the contents of Para 5 of the said notice may be replaced by the following:
 - "5. Thus, it is clear that the candidate has indulged in the following activities amounting to impersonation:
 - i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
 - ii) Allowing/making somebody else to write answers on candidate's behalf during examination.
 - iii) Helping or receiving help from other candidates to impersonate.
 - iv) Signing/getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
 - v) Providing admit card to another person to enable him to appear on behalf of the candidate".
- 4. Furthermore, contents of Para 7 of the said notice may be replaced by the following:-

"Therefore, it is evident that the candidate/impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code".

- 5. The other contents of the said notice shall remain unchanged.
- 6. This issues with the approval of the Competent Authority.
