The competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The selection/appointment of above mentioned candidate shall further be subject to outcome of the clarification from Hon'ble High Court of Delhi in the case in of Deepak Kumar & Ors V/s DSJ in CM APPL 11943/2013 and 11944/2013 in WP© No. 5390/2010 and also outcome of any other decision in various writ petitions pending before Hon'ble High Court Delhi/Supreme Court of India on this issue.
