NOTICE/ORDER

WHEREAS, as per requisition received from the Directorate of Education, GNCTD, the DSSSB vide its Advertisement No.04/17 dated 20.12.2017 advertised posts of TGT (Natural Science) in the Directorate of Education under Post code 135/17.

AND WHEREAS, online applications were invited for the post code 135/17 and all candidates of Advt. No.04/17 (which included post code 135/17 also) submitted their application on OARS portal.

AND WHEREAS, Sh. Mohan Lal Chhedwal (in SC Category) applied for the post of TGT (Natural Science) under post code - 135/17 and allotted roll no 120113501305.

AND WHEREAS, examination for the post code 135/17 was conducted on 29.09.2018. Thereafter, a general notice dated 18.02.2019 was published on the website of the Board informing them that the mark list has been uploaded on the website and the shortlisted candidates were asked to fill e-dossier upload all the relevant documents. Since, Sh. Mohan Lal Chhedwal failed to upload e-dossier during the stipulated time (i.e. 27.02.2019 to 08.03.2019), his candidature for the post of 135/17 could not be considered.

AND WHEREAS, prescribed cut off marks for uploading e-dossiers were 85.45 marks. The marks of the last selected candidate in post code 135/17 in SC Category were 91.66 marks and Sh. Mohan Lal Chhedwal had secured 88.51 in SC category which is below marks than the last nominated candidate.

AND WHEREAS, in compliance of order dated 02.08.2024 of Ld CAT in OA No. 1076/2019, order dated 11.12.2024 in WPC No. 17117/2024 &order dated 25.07.2025 in Review Petition no. 165/2025 of Hon'ble High Court the candidature of Sh. Mohan Lal Chhedwal is considered. As the marks of last nominated candidate i.e. cut off in SC category is 91.66 vide last Supplementary Result No. 810 dated 21.09.2021 and Sh. Mohan Lal Chhedwal secured 88.51 marks.

NOW THEREFORE, The candidature of Sh. Mohan Lal Chhedwal cannot be nominated for the Post of TGT (Natural Science) under Post Code 135/17 on the basis of merit in his category as he is not found above the cut off marks for nomination.

This issues with the prior approval of the Competent Authority.
