Sub:- Regarding cancellation of Rejection Notice dated 19/12/2022 alongwith revival of candidature of Sh. Mandeep Singh S/o Joginder Singh in r/o Physical Education Teacher, (PET) post code 87/20, in Directorate of Education.

In pursuance of letter from examination branch vide No.F.55(277)/Exam/DSSSB/2021/103-114 dated 20/02/2025 regarding withdrawal of debarment order in r/o Sh. Mandeep Singh S/o (DOB 28/04/1993) and OA No. 2648/2021 dated 20/12/2024 titled Mandeep Singh V/s DSSSB & Ors., the Rejection Notice No. 895 dated 19/12/2022 in respect of post of PET, post code 87/20 of Directorate of Education is hereby rescinded for further necessary action by the user department, Directorate of Education.

Earlier, DSSSB vide Rejection Notice No. 895, dated 19/12/2022 cancelled the candidature of Sh. Mandeep Singh in r/o of post code 87/20, for the post of PET in Directorate of Education on the basis of debarment order dated 02/09/2021 issued by Exam Branch debarring him from any examination conducted/to be conducted by the DSSSB for lifetime w.c.f 24/10/2019. Now the said letter has been withdrawn retrospectively vide order No.F.55(277)/Exam /DSSSB /2021/103-114 dated 20/02/2025.

Hence, the Rejection Notice dated 19/12/2022 is rescinded and candidature in r/o Sh. Mandeep Singh S/o (DOB 28/04/1993), Roll. No. 121108700136 is hereby revived for further necessary action, to be taken by the User Department i.e. Directorate of Education.
