**KIND ATTENTION: CANDIDATES FOR THE POST OF SPECIAL EDUCATOR, POST CODE-15/17
IN MUNICIPAL CORPORATION OF DELHI**

The DSSSB vide its advertisement No. 02/2017 dated 07/08/2017 had advertised total **1540** [UR-773, OBC-426, SC-226, ST-115 (including PH/OH-24 & PH/VH-25)] for the post of **Special Educator under Post code-15/17** in MCD with closing date as **15.09.2017**. Tier-I examination in online computer based examination mode was conducted on **22.07.2018**.

2. On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of Special Educator, Post Code-15/17 in MCD and the terms and conditions of the advertisement, the candidature of 60 following candidates in respect of the above said post code was rejected for the reason/ remarks mentioned against his/her roll number:-

4. In compliance of the direction of the Hon'ble High Court in W.P. (C) No. 9040/2019 titled as Praveen Khatri and Ors Vs. Govt. of NCT of Delhi & Ors, the User Department i.e. MCD had sent a proposal to the Hon'ble Lt. Governor, Delhi through Director (Local Bodies) to grant relaxation as per power confirmed in Clause 5 of RRs to the post of Special Educator (Primary) in Municipal Corporation of Delhi.

5. Now the South Delhi Municipal Corporation vide their communication bearing No. D/DDE/Admin/Edu. /HQ/SDMC/2020/93 dated 08/07/2020 has communicated to the Board as follows – **"... in compliance of the direction passed by the Hon'ble High Court of Delhi dated 21.03.2019 in W.P. (C) No. 9040/2019 titled Praveen Khatri and Ors Vs. Govt. of NCT of Delhi & Ors, the Education Department of South Delhi Municipal Corporation had sent a proposal to the Hon'ble Lt. Governor, Delhi through Director (Local Bodies) to grant relaxation as per power confirmed in Clause 5 of RRs to the post of Special Educator (Primary) in Municipal Corporation of Delhi (2012) (South, East and North Delhi Municipal Corporation) in the following matters –**

1. **To consider the CTET qualification of the candidates who are otherwise qualified and obtained the CTET qualification after the cut off date but before their appointment to the post of Special Educator (Primary) under post code 15/17.**
2. **To relax the age of candidates who are otherwise qualified for appointment to the post of Special Educator (Primary) under post code 15/17.**

In this regard, Hon'ble Lt. Governor, Delhi has granted onetime relaxation of age and CTET qualification to the otherwise qualified candidates who have obtained the CTET qualifications after the cutoff date but before their appointment and age relaxation even if they may have become overage for the post of Special Educator (Primary) as advertised vide post code no.15/17.

Further, grant of age relaxation to the candidates, otherwise eligible, has been considered on same lines as done by Education Department, GNCTD recently for Special

Education Teachers vide order has been considered vide No. F. 209/DDE (IEDSS)/Court File/2016-17/CD No. 043457883/9831-37 dated 06.12.2019.

This shall not be treated as precedent for any future recruitment for the post or any other posts.

The Office Order in this regard has been issued by Dy. Director (Local Bodies vide No. F. CD No. 000583201/18194-18198 dated 13.03.2020....."

6. Accordingly, the candidature of those candidates whose candidature were rejected for not having CTET /CTET after cutoff date or being overage, has been considered in the light of order dated 13.03.2020 issued by Dy. Director (Local Bodies) and the rejection notices in respect of the candidates mentioned above is rescinded for the post of Special Educator, post code-15/17. The candidature of these candidates has been revived for the post of Special Educator (Primary) Post Code-15/17.

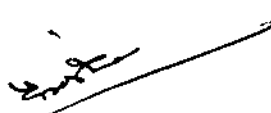
