## CANDIDATURE CANCELLATION NOTICE No. 1042 GRADE IV (DASS) (POST CODE 02/17) IN SERVICES DEPARTMENT

- 1. It is stated that all candidates who appeared in the Skill Test held on 24/12/2019, 26/12/2019, 27/12/2019, 28/12/2019, 29/12/2019, 30/12/2019, 03/01/2020, 04/01/2020 and 16/02/2020 for the post of Grade IV (DASS) in Services Department under Post Code 02/17 were given clear instructions through General Instructions to candidates for Skill Test (Shorthand/Typing) for the various post codes of various Department of GNCT of Delhi issued vide F.55(1474)/Exam/DSSSB/2019/2571 and 2572 dated 20/11/2019 including the following specific directions:
  - "10. The Candidate should not bring any article such as books, notes, loose sheets, etc. in the examination hall.
  - 20. If any candidate is found using any unfair means or impersonation he/she will be debarred from all examination of DSSSB and/or necessary legal action be initiated.
  - 28. The Board reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment. Further, candidature of every candidate is purely provisional, at every stage until he is offered appointment by the concerned Department to which the post belongs, after due verification of documents and eligibility in respect of the post.
  - 29. Prohibited Items for Candidates in the Exam. The candidates are not allowed to carry any communication device like Mobile Phone, etc. and any other items which may cause hindrance to conduct of examination."

Whereas, the candidate Sh. Sanjeev, DOB:-15/01/1990, S/o Mangat Ram having Skill Test roll no. 4640001019 violated instructions of the Board during the skill Test on 24/12/2019 in the at Indira Gandhi Delhi Technical University for Women, Kashmere Gate, Delhi under Post Code 02/17, i.e., Grade-IV (DASS) in Service Department by bringing mobile phone in the exam hall. The candidate also took the photo of the screen which he has typed. The candidate was caught taking photograph of screen by the exam functionaries in the Exam hall.

Whereas, the above-said Guidelines clearly instructs to all candidates that "The Board reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment. Further, candidature of every candidate is purely provisional, at every stage until he is offered appointment by the concerned Department to which the post belongs, after due verification of documents and eligibility in respect of the post.

In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of misconduct, indiscipline and violation of General Instructions of



DSSSB is made out against the Candidate Sh. Sanjeev, DOB:- 15/01/1990, S/o Mangat Ram which may had caused hindrance to conduct of free and fair examination.

The DSSSB adheres to **ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT** by any candidate or any persons. Therefore, in view of the above facts and circumstances, the candidature of the candidate Sh. Sanjeev, , S/o Mangat Ram having Date of Birth 15/01/1990 bearing Skill Test roll no. 4640001019 and Written Examination Roll No. 12330215756 of post code 02/17 is hereby cancelled.
