Section Officer (Hort.), (Post Code 28/12) In Municipal Corporation of Delhi (MCD)

- The DSSSB vide its Advertisement No. 02/2012 with closing date 15/06/2012 had advertised 44 vacancies (UR-24, OBC-15, SC-05 including PH(OH)-02) for the post of Section Officer (Hort.) in MCD under Post Code 28/12.
- Board Conducted Tier-I written examination for recruitment in respect of this post on 06/10/2019 and 28 candidates were shortlisted for appearing in Tier-II Examination for the said post vide Notice No. 847 dated 06/12/2019.
- Board has conducted Tier-II written examination (offline mode) of shortlisted candidates on 23/02/2020.
- 4. Marks obtained by 25 candidates who have duly appeared in the Tier-II written examination held on 23/02/2020 have been uploaded on Board's website. Candidate can view their marks by logging in to their account in OARS module on www.dsssbonline.nic.in.
- 5. Based on the performance in the Tier-II Examination, 07 candidates (UR-03, OBC-02, SC-02) who have secured equal and more marks in their respective category as per details given below are being provisionally shortlisted and accordingly, allowed to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form:-

- 6. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Shortlisting is being made on the basis of marks obtained in Tier-II examination (Technical) for 200 marks.
- Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 5 above.
- All the candidates who have been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.



- 9. The e-dossier link shall be active from 15.09.2020 to 29.09.2020. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 15/06/2012.
- 10. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- All the candidates who have shortlisted for uploading e-dossiers MUST upload their all requisite/applicable documents in the said link in stipulated time i.e. <u>15.09.2020 to</u> <u>29.09.2020</u>.
- 12. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.
- 13. The above shortlisting of candidates for calling of e-dossier for the post code -28/12 will be subject to outcome of pending court cases, if any.
- While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
