NOTICE

Subject:- Declaration of Marks of offline Tier-II examination held on 01.03.2020 for the Post of Manager (Managerial Service Cadre), Post Code-59/15 in Delhi States Civil Supplies Corporation—regarding.

The DSSSB vide its advertisement No. 01/2015 had advertised **03** (**UR-02**, **OBC-01**,) for the post **Manager (Managerial Service Cadre) in DSCSC under Post Code-59/15**. Offline Tier-I written examination was held on 29.09.2019 and Tier-II Technical Descriptive examination was held on 01.03.2020.

- 2. Further, as per new examination scheme already given in advt. no. 01/15 (annexure-I), Three Tier examination was prescribed as Tier-I (objective), Tier-II (Objective + Descriptive) & Tier-III (Interview). However, as per notice dated 02/06/2017 of the Board followed in pursuance of DoPT instructions vide O.M. No. 39020/01/2013-Estt (B)-Part dated 29/12/2015, interview from selection process in respect of all posts have been dispensed. As such, Three Tier examination scheme has been converted into Two-Tier examination scheme with immediate effect and final selection shall be made based on the merit in Tier-II examination.
- **3.** Accordingly, the marks obtained by **26 candidates** who duly appeared in Tier-II Technical Descriptive Examination conducted **(offline mode) on 01.03.2020** have been uploaded on the Board's website. Candidate can view his/her marks by logging into his/her account in OARS module on www.dsssbonline.nic.in.
- 4. Based on the performance in <u>Tier-II Technical Descriptive Examination</u>, 13 candidates as informed in their OARS module have been provisionally shortlisted who obtained marks above or equal to cutoff marks in their respective category, as detailed below, have been provisionally shortlisted to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

- 5. The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-II Technical (Descriptive) examination for 250 marks.
- 6. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.

- 7. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time.
- 8. The e-dossier link shall be activated for a period of 15 days w.e.f. 16/09/2020 to 30/09/2020.
- 9. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 26.11.2015 as per Advertisement No. 01/15. The shortlisted candidate is also being separately informed through SMS & E-Mail on his registered mobile number & e-mail id. (as an additional facility). If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 10. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
- 11. While every care has been taken in preparing the list of shortlisted candidate, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
- 12. The above shortlisting candidates for uploading of e-dossier for the post of Manager (Managerial Service Cadre) under post code-59/15 in DSCSC is subject to outcome of pending court case, if any.
