Subject: - Corrigendum to Notice No. 83 for release of marks and shortlisting of candidates for Tier-II Exam for the post of Office Superintendent in DTC Post Code 08/20

- 1. This Notice is issued as Corrigendum to Notice No. 83 dated 03.01.2022 in respect of candidates shortlisted under EWS Category and the marks obtained by the last shortlisted candidate in that Category.
- 2. The revision under EWS Category had to be made as the minimum cut-off for the Category is 40% as applied to the candidates in UR Category. Two Ex-Serviceman candidates in EWS Category who had scored below 40% score were included in the shortlisted candidates in Notice No. 83 but due to the fact that the post is not reserved for Ex-Servicemen, the benefit of 5% relaxation in marks to Ex-Servicemen cannot be allowed.
