V/s DSSSB & ors..

Selection of following eight candidates (Roll numbers/Sr. No. in select list:) 2356393(UR-04), 3813111(UR-07), 2387929(UR-26), 2357801(UR-147), 2328537(UR-208), 2332920(UR-242), 2387567(OBC-30) & 6310683(OBC-50) who were declared provisionally selected to the post, as per result notice dated 10.03.2010, is hereby rescinded as the candidates were found involved in malpractice in examination of the post codes. Pending result of ten candidates (Roll number 2330974, 2334605, 2383626, 5412442, 2386238, 2356187, 2333466, 2334358, 2384252, 2334288 and 2383383) is hereby cancelled as the candidates were found involved in malpractice in examination of the post codes. Result of remaining pending cases shall be declared in due course after completing the due process of verification..

The selection of the above 11 candidates (UR-05, OBC-06) shall further be subject to these candidates fulfilling the eligibility conditions of the post, as prescribed by the statutory RRs and term and conditions of advertisement as indicated in the advertisement inviting applications and also subject to through verification of their identity with reference to their photographs, signatures, handwriting and thumb impression etc., on the application forms, admission certificates etc. The candidature of the candidates are liable to be cancelled by the user Department also, in case candidates found not fulfilling the eligibility conditions or any other genuine reasons. The Competent Authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
