## DELHI SUBORDINATE SERVICES SELECTION BOARD GOVT. OF NCT OF DELHI FC-18. INSTITUTIONAL AREA, KARKARDOOMA, DELHI-92

## ORDER

The Ld. CAT vide its order dated 18-09-14 in OA No. 2574/2013 titled Shabana Parveen Vs. Secretary, DSSSB directed to examine the claim of the applicant to the post of PGT (Economics) in the light of Hon'ble CAT order dt. 29.2.2012 in OA No. 1493/2011 in the matter of Lokesh Kumar V/s DSSSB & Ors. In pursuance of the same the following is informed:-

In the matter of Lokesh Kumar, the DSSSB as per requisition of DJB i.e. user deptt, advertised 2 vacancy (OBC-1, SC-1) for the post Assst. Chemist under Post Code 152/05. The Board declared the result on 1.4.15, and Pratap Singh Yadav with marks 37.75/80 got 1<sup>st</sup> Rank in OBC. The document of Ist rank holder alone were scrutinized due to only 01 vacancy in OBC and found that he did not enclose the copy of OBC certificate in support of his claim. His candidature was therefore, kept pending for clarification. After receipt of clarification, the DSSSB found that Pratap Singh Yadav was not eligible for the post and closed the recruitment process as there was no policy of panel of waitlist candidate at that time. Sh. Lokesh Kumar who got marks 35/80 ranked 2<sup>nd</sup> in OBC was not considered due to only one vacancy in OBC category. Lokesh Kumar approached the Hon'ble CAT and it has been ordered:

Respondent shall treat the applicant as the first eligible candidate who secured the first position in the merit list and accordingly it shall forward his name to the user deptt for appointmet.

As the fresh requisition had not been received, till the declaration of Hon'ble CAT order, from the DJB for the post of Asstt. Chemist, the Board declared the result of Lokesh Kumar in compliance of Hon'ble CAT and recommended for provisinal selection.

Whereas, in the matter of Shabana Praveen, the Board had advertised 11 vacancies (UR-06, OBC-03 & SC-02, including OH-01) for the post of PGT (Economics) under post code 32/10 in Dte. of Education vide its advertisement No. 002/2010. Combined Preliminary and Main Examination was held on 18.12.2011. The Part-I result was declared on 09.03.2012 vide result notice No. 261 dated 09.03.2012 in which total 120 candidates were shortlisted (UR-63, OBC-33, SC- 20 & PH(OH) 4) in respect of post code 32/10. On the basis of marks secured by them in Part-II Examination , Descriptive (Main) the merit list of 28 candidates were prepared and from this merit list 09 candidates (UR-03, OBC-03, SC-02 & UR/OH-01) were provisionally selected. The result of 02 candidates in UR category were kept pending due to various reasons under post code 32/10 vide result notice no. 289 dated 17.08.2012.

Whereas out of these 2 pending candidates in the result notice 289 one candidate Ms Sarabjeet Kaur was provisionally selected vide office order No. 310 dated 13.02.2013 and second candidate Ms. Nisha was found 'Not Eligible' and rejected vide Rejection/Office Oder No. 312 dated



13.02.2013. Further at that time there was policy by which no waiting panel /list was prepared and kept valid. This policy had continued to be reaffirmed by the Board before the notification dated 13.06.2013. As the recruitment process had been closed, the vacancy of this Post Code was intimated to User Department. Further, the user deptt had also sent fresh requisitions subsequent to this Post code which have been advertised for the post of PGT (Economics) vide Post Code No. 130/12, 131/12, 165/14 & 166/14, the Tier-I and Tier-II exam for the same have already been conducted and the final result is going to be declared very shortly. The candidature of Shabana Parveen under Post Code32/10 PGT (Economics) in such circumstances cannot be considered and hence rejected.

This issues with the prior approval of the Competent Authority.
