Candidates for the post of PGT (Computer Science), Female, Post Code- 71/20– regarding.

Reference Notice No. F. No. 281/Result/ PGT (Computer Science)/Female/CC-III/DSSSB/2021-22/1242-50 dated 23.09.2021, the shortlisted candidates for the post of PGT (Computer Science) Female, post code-71/20 were asked to upload their documents in the edossier w.e.f. 29.09.2021 to 13.10.2021.

2. On scrutiny of the documents in the e-dossier, it has been noticed that the some of the candidates have uploaded their e-dossier with deficient documents and accordingly, their candidature has been kept pending for want of deficient / requisite documents in the e-dossier. Therefore, the candidates detailed given below are being given 1st opportunity w.e.f. 22/10/2021 to 31/10/2021 to upload the deficient /requisite documents. However, out of 03 pending candidates, the following 01 candidate are still kept pending for want of deficient /requisite documents in the e-dossier as mentioned against their roll numbers, in the e-dossier:-

Tech (Computer Science/IT) plus Post Graduate Diploma in Computer Applications or B or C Level Diploma from DOEACC, Ministry of Communications and IT plus One Year Teaching Experience OR (ii) M.Sc. (Computer Science)/MCA plus One Year Teaching Experience OR (iii) Master of Engineering or M. Tech (Computer Science/IT) required. Hence, the candidate was given 1 st opportunity to upload the requisite documents alongwith their marks sheet in the e-dossier w.e.f. 22.10.2021 to 31.10.2021.But she failed to upload requisite documents mentioned above. Hence 2 nd and final opportunity is being given to her (from 23/11/2021 to 27/11/2021)

- 3. The above 01 candidate is being given 2nd opportunity w.e.f. 23/11/2021 to 27/11/2021 to upload the deficient /requisite documents in the e-dossier, failing which her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 4. The e-dossier link shall be activated to the above 01 pending candidate only for a period of 05 days w.e.f. 23/11/2021 to 27/11/2021.
- 5. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 23.02.2020 as per Advertisement No. 04/2020.

6. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her deficient documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
