**RESULT NOTICE NO 261**  
**PHARMACIST (HOMEOPATHY) POST CODE 01/08**

Whereas Hon'ble High Court of Delhi while disposing the court case No. WP(C) No. 2552/2012 in the matter of DSSSB v/s Rajni & ors vide its order dated 05.03.2013 has directed that henceforward DSSSB would maintain a reserve list. The operative part of said order is reproduced hereunder:

"We thus dispose of writ petition holding the office order dated July 04, 2008 to be arbitrary and direct that henceforward DSSSB would maintain a reserve list. As regard the instant case, we modify the direction issued by the Tribunal to issue letter offering appointment to two unreserved candidates. We substitute the direction to the Board adjust either OBC or SC or ST candidates as per the marks obtained by them against unreserved vacancies yet to be filled up and thereafter issue letters offering appointment to other OBC/SC or ST candidates as per the marks obtained by them against unreserved vacancies yet to be filled up and thereafter issue letters offering appointment to other OBC/SC candidates in their respective quota. Under all circumstances the notified posts would be filled up".

In compliance of above said order and in continuation to the Result Notice No. 224 dated 21/ 8/2013 the selection of 01 candidate under post code 01/08 against the 02 vacancy so created due to shifting of 02 OBC candidates in UR category the selection of one candidate with the following particulars has been provisionally selected to the post of Pharmacist (Homeopathy) in D.I.S.M & H., Govt. of NCT of Delhi in the Pay Scale of Rs. 4500-7000 (Pre-revised) under post code 01/08 with respect to direction of Hon'ble High Court of Delhi vide order dated 05.03.2013 in WPC no. 2552/2012 in Para 14.

The competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. The user department shall also get the OBC certificate verified from the issuing authority before his appointment.

Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.
