DRAWING TEACHER, POST CODE-91/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total 295 vacancies (UR-105, OBC-122, SC-48 & ST-20 (including PH/OH-05 & PH/VH-04) for the post of **Drawing Teacher under Post Code-91/17** in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on **29.09.2018**.

- 2. On the basis-of online examination of Tier-1 held on 29.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of Drawing Teacher under Post Code-91/17 in Directorate of Education, 165 candidates (UR-90, OBC-15, SC-42, ST-15, PH-OH-03) were provisionally nominated vide Result No.443 dated 27/05/2019 and the candidature of 18 candidates [UR-07, UR(PH-OH)-01,OBC-04, SC-05 and SC(PH-OH)-01] were kept pending for want of documents and their documents were recalled w.e.f. 29.05.2019 to 07.06.2019. Further, the candidature of 01-OBC category candidate was also kept pending for verification of her OBC (Delhi) status from Revenue department.
- 3. Out of these 18 candidates, whose candidature were kept pending for deficient documents, 11 candidates have uploaded the requisite documents and after scrutiny of the documents uploaded by these candidates, 09 candidates[UR-02, UR(PH-OH)-01,OBC-02, SC-03 and SC(PH-OH)-01)]were found eligible and is being provisionally nominated and candidature of 02 candidates (UR-01 & SC-01) is being rejected for not fulfilling terms and conditions of RRS for the post code 91/17. Consequent upon rejection of 02 candidates, 01 candidate under SC category immediately available below last nominated candidate is also being nominated as there is no waiting panel available under UR category.
- 4. Further, the candidature of 01 candidate of OBC category was kept pending earlier for want of verification of her OBC status. Since the verification of OBC status from Revenue Department is taking considerable period of time and delaying the recruitment process, the Board has decided to provisionally nominate these candidates and the User department may verify the OBC status of the candidates from the Revenue department as per the guidelines issued by GNCT of Delhi vis a vis documents filed by the candidates with regard to his/her place of birth and

educational qualifications before issuance of offer of appointment in terms of MHA OM No.2/29/54-RRs 19-11-54. Thus, **01 candidate under OBC category** is also being nominated.

5. Accordingly, in continuation to Result Notice No.443 dated **27.05.2019**, the following candidates detailed below are also provisionally selected on the basis of off-ine examination of Tier-I held on 29.07.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification etc. in accordance with advertisement No.04/2017 and RRs for the post of **Drawing Teacher, Post Code-91/17**, as detailed below:-

- The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification identity with reference to their of their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the-offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also

requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008, O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Goyt, of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 11. The user department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 12. Further, the candidature of 07 candidates is kept pending for insufficient documents, as per details given below. They are being given second and final opportunity to upload pending/ requisite/applicable documents in the e dossier module within the stipulated time, i.e. from 18.03.2020 to 25.03.2020 failing which their candidature will be rejected and no further opportunity will be given whatsoever ground:-
