# MASON, POST CODE-157/14 IN NEW DELHI MUNICIPAL COUNCIL

The DSSSB vide its advertisement No 01/14 dated 12/12/2014 had advertised 49 {UR-29, OBC-14, SC-03, ST-03) for the post of Mason in New Delhi Municipal Council under Post Code-157/14. Further, vide addendum dated 31.10.2019, the notified vacancies had been revised 52 vacancies (UR-29, OBC-14, SC-05, ST-04). Tier-I offline written examination was held on 03.11.2019.

- All 21 candidates who had appeared in written examination were informed through notice No. F.No. 221/Mason/Result/Int. Cell/DSSSB/2019-20/335-42 dated 16/01/2020 on the Board's website i.e. www.dsssb.delhi.gov.in that their marks for the examination dated 03.11.2019 for the post of Mason, Post Code-157/14 have been declared and the same were available in their account in OARS module. Further, vide said notice, 01 shortlisted candidate who qualified the written examination was given the opportunity to upload his documents in the e-dossier module w.e.f. 23.01.2020 to 06.02.2020 with the specific direction that if the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground. The shortlisted candidate has uploaded his documents in the e-dossier portal. The candidate has uploaded his e-dossier within the stipulated time period. On scrutiny of the documents, it has been found that he has not uploaded 05 years experience certificate in the relevant field as per recruitment rules for the above post code Hence, his candidate was kept in pending and was given 1st opportunity to upload the deficient documents in the e-dossier. His e-dossier was recalled w.e.f. 11.03.2020 to 20.03.2020. The candidate has now uploaded the deficient /requisite documents in the edossier
- 3. On the basis of marks secured in the written examination and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post and the terms and condition of the advertisement, the following 01 Candidate under SC category is provisionally selected for the post of Mason, Post Code-157/14 in New Delhi Municipal Council subject to his fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in his online application form and e-dossier:-

4. \* As per RRs one of the essential qualifications is 05 years experience in the trade of Mason in reputed establishment. As the user department has not provided any specification to check the experience in Mason, the DSSSB has not undertaken the veracity/scrutiny of experience certificate furnished by the candidate as such user department i.e. New Delhi Municipal Council is requested to ascertain the scrutiny/correctness of the same at their own level

before issuing the offer of appointment to the proposed candidate. The selection is provisional and subject to the satisfaction of user department regarding experience certificate furnished by above candidate.

- 5. The essential qualification for the above post code is referred as:-
- (A) (i) Persons having certificate in the trade from recognized institution. (ii) At least One year practical experience in the trade of Mason in reputed establishment. **OR**
- (B) (i) Literate person who can read and write Hindi/ English. (ii) Should have 05 years experience in the trade of Mason in reputed establishment. (iii) Should be qualified the prescribed trade test
- 6. The above nominated candidate fulfills condition mentioned in the SI. No. 1 & ii of part B. As regard to condition given at SI. No. iii i.e. qualified the prescribed trade test, the user department i.e. New Delhi Municipal Council is requested to conduct the prescribed trade test at their level before issuing any appointment letter. If the candidate does not fulfill the essential criteria, his candidature may be cancelled at their level under intimation to the DSSSB.
- 7. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc on the application form, admission certificate etc. The candidature of the above candidate are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 8. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 9. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various

## Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 10. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 12. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 13. The result process for the above post code stands closed in all respect.
- 14. There is no waiting panel in the merit as only one candidate has qualified the written examination who has been nominated for the above post code.
- 15. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
