NOTICE NO. 1070 GRADE-II (DASS) (POST CODE 81/17) IN SERVICES DEPARTMENT

- 1. The DSSSB vide its Advertisement No. 03/17 with closing date 21/11/2017 and addendum dated 09/07/2019 had advertised 266 vacancies (UR-135, OBC-78, SC-34, ST-19 including ExSM-48, Sport Person-11, OH-2, HH-06, VH-08) for the post of Grade-II (DASS) in Services Department under Post Code 81/17. Board Conducted Tier-I written examination for recruitment in respect of this post from 16/07/2019 to 19/07/2019 and 22/07/2019 to 25/07/2019.
- 2. The online Tier II examination was held on 08/11/2019. The marks statements of the above Post/Post Code have been uploaded on the Board's website for information of the candidates. Candidates can view their marks by logging onto their account in OARS module on www.dsssbonline.nic.in.
- 3. Based on the performance in Tier-II written examination, all qualified 2296 (Two thousand Two Hundred Ninty Six) candidates as detailed below, have been provisionally shortlisted to upload their requisite documents. All qualified candidates for the above-mentioned post/post code are hereby directed to log on to the e-dossier module and up-load all the documents of Educational Certificate/Certificates and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.

- 4. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying Tier II examination does not entitle them to any right to the post.
- 5. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in two Tier written examination for UR Category Candidate is 40%, for OBC Candidate is

- 35% for SC/ST/PH candidate is 30% and for EXSM category candidate is 5% relaxation in their respective categories subject to a minimum of 30%.
- 6. All qualified candidates have been shortlisted to upload their documents in their respective e-dossier Link as per Examination scheme published by the Board vide Advertisement No. 03/17 which is reiterated as "For the Post of Grade II (DASS), based in the Merit on Tier II examination candidates will be instructed to upload their documents on the website of the Board. For candidates found eligible after verification of documents, numbering 1.25 times of vacancies, exit exam shall be conducted so as to fill vacancies and prepare waiting panel. All those qualify in Exit Exam/Writing Skill Test shall be provisionally selected or shall be part of the waiting panel as per the vacancy."
- 7. Notice for shortlisting of eligible candidates for appearing in Exit Exam/Writing Skill Test in the post code will be issued separately, after proper examination of documents submitted by the candidates and being found eligible as per Requirements of RR, various DoPT guidelines and other requirements advertised by the Board, as per their merit on the basis of marks obtained by them in Tier II Exam held on 08/11/2019.
- 8. The result is subject to the outcome of OA No. 1390/2019, M.A. 2517/2019, O.A. No. 1376/2020, M.A. 1719/2020 and any other Court Cases pending in various courts related to this Post.
- 9. In view of Interim order of the Ld. CAT in OA No. 3158/2019 in the matter of Sandeep Kumar Sharma and Ors V/s DSSSB and MA No. 3010/2018 OA No. 2700/2018 in the matter of Apoorva Gupta V/s Govt of NCT of Delhi, the provisional admit cards were issued to 08 candidates bearing roll nos. 12321001836, 12321001837, 12321001839, 12321001838, 12331000778, 12331000779, 12331000780, 12331000781.
- 10. The candidates who were provisionally allowed to appear in Tier II examination on the interim directions of the court, and is/are in the zone of consideration, their e-dossiers are being called, however their candidature will be subject to outcome their pending court cases.
- 11. Kindly note that the e-dossier link will be activated in respect of only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 3 above.
- 12. All the candidates who have been shortlisted for uploading e-dossier MUST upload their all requisite/applicable documents in the said link within the stipulated time period.
- 13. The e-dossier link shall be active from 19/10/2020 to 02/11/2020. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 21/11/2017.
- 14. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during their above said period, his/her



- candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 15. All the candidates who have shortlisted for uploading e-dossiers MUST upload their all requisite/applicable documents in the said link in stipulated time i.e. 19/10/2020 to 02/11/2020
- Mere seeking of documents from the candidate for up-loading documents in the edossier module does not confer upon him/her any right to be shortlisted for appearing in Exit Exam/Writing Skill Test/ provisional selection to the applied post. Final selection will be made purely on the basis of being qualified in the Exit Exam/Writing Skill Test and as per their merit of Tier II Examination; against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.
- 17. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
