SUPPLEMENTARY RESULT NOTICE No.-1038
ASSISTANT SUPERINTENDENT (POST CODE- 38/13)
IN DELHI PRISONS DEPARTMENT

1. The DSSSB vide its advertisement number 02/2013 with closing date 02/08/2013, had advertised 35 vacancies (UR-19, OBC-09, SC-05, ST-02, out of which 04 vacancies were reserved from EXSM) for the Post of Assistant Superintendent in Delhi Prisons Department in the pay scale of Rs. 5200-20200 having Grade pay of 2800/- (Group-C Jail cadre).
2. The Board had conducted the written examination on 09.03.2014 for the post of Assistant Superintendent under post code 38/13. On the basis of the written examination the candidates were shortlisted to appear for PET, which was qualifying in nature. After conducting the Physical Endurance test (PET-I, PET-II & PET-III) in respect of shortlisted candidates from 16/03/2015 to 22/03/2015, then from 12/07/2016 to 13/07/2016 and also on 16/02/2018, 34 candidates who qualified the PET were nominated to the post of Assistant Superintendent under post code 38/13 vide Result Notice Nos. 342 dated 15/10/2015, 350 dated 18/12/2015, 367 dated 14/01/2016, 415 dated 28/07/2016, 511 dated 16/05/2017, 679 dated 30/06/2018 and 733 dated 14/11/2018.
3. In view of unfilled vacancies including vacancies arose due to cancellation of candidature of 11 candidates by User Department, 373 candidates were shortlisted for appearing in PET-IV under post code 38/13, vide notice no. 705 dated 23/08/2018 and addendum dated 31/08/2018.
4. The PET-IV was conducted from 18/09/2018 to 20/09/2018. The result of PET-IV was declared vide notice no. 732 dated 14/11/2018 and candidates shortlisted for uploading e-dossier.
5. DSSSB vide Result Notice No. 756 dated 07.01.2019 selected 07 candidates and withheld 02 vacancy in UR Category and 01 in SC Category in compliance with the interim order of Ld. CAT in O.A. Nos. 35/2017 and 4312/16 respectively. Further, 01 more vacancy in UR category was also kept withheld as representation of earlier selected UR candidate having roll no. 13000906 was also under examination with the Board.
6. Ld. CAT vide final order dated 14.02.2019 dismissed the OA No. 35/2017 in the matter of Kuldeep Kadyan Vs. DSSSB.
7. Further, final order of Ld. CAT in O.A. No. 4312/16 in the matter of Pawan Vs. DSSSB is still awaited, hence, 01 vacancy in UR Category and 01 vacancy in SC Category is still kept withheld.
8. Further, Sh. Arvind Kumar Tomar (13000906) was earlier selected in UR Category to the post of Assistant Superintendent under postcode 38/13 vide result notice number 415 dated 28.07.2016, his dossier was returned by the Prisons Department vide their letter dated

13/07/2017 after cancellation of his candidature as the candidate not reported to join the post. Keeping in view the representation dated 04/06/2018 of Arvind Kumar Tomar (13000906), 01 vacancy in UR category was withheld vide Result Notice No. 756 dated 07/01/2019 and subsequently the User Department was requested to send their recommendation to reconsider his candidature in Post Code 38/13.

9. Now, as the User Department vide its letter dated 09/10/2019 has informed that the candidate did not reported for acceptance of offer of appointment in spite of giving reminder/final reminders hence, the candidature of the candidate was cancelled by the Prison Department. Accordingly, the post which was kept withheld in view of representation of Arvind Kumar Tomar is now treated as vacant before expiry of the waitlist panel and a candidate from waitlist panel is proposed to be selected provisionally in UR category against the returned dossier of Arvind Kumar Tomar.

10 User Department, i.e., Delhi Prisons Department, Govt. of NCT of Delhi returned 03 dossiers (OBC-03) before expiry of waitlist panel on the grounds that candidates not responded/shown willingness to join to the post of Assistant Superintendent. The dossiers were returned before the expiry of waitlist panel. Hence, the Board is declaring the Result of Panel/waitlisted candidates as per their merit.

11. After preliminary scrutiny of the Candidature of the candidates on the basis of documents uploaded/provided by them in their e-dossier as per the provisions of the statutory requirements rule for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of Assistant Superintendent in Delhi Prisons Department under post code 38/13.

12. The selection of the above 05 candidates (UR-02, OBC-03) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. Further, the User Department shall arrange measurement of physical standards, i.e. weight and chest and also checking of defects or deformity (including bow-legged, knocked knees, flat feet, etc.) of the candidates as per the requirements of the RRs, which has not been done by the DSSSB, before issue of appointment order/s.

13. The Selection of the above 05 candidates (UR-02, OBC-03) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and

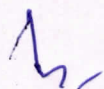
conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

14. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Delhi Prisons Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
 15. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
 16. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
 17. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
 18. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

19. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
20. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
21. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
22. The category wise marks scored by the last candidate provisionally nominated are as under:-
