The candidate was again given 2 nd and final opportunity w.e.f. 20.09.2020 to 03.10.2020 but he failed to upload the deficient documents in the e-dossier. Hence, his candidature is rejected for being overage.
2	2680020342	Overage. The candidate has however, applied under GCT category but not uploaded any relevant documents. The candidature of the candidate was kept pending for want of experience under GCT category by giving 1 st opportunity w.e.f. 31.05.2019 to 09.06.2019 but he failed to upload the same. The candidate was again given 2 nd and final opportunity w.e.f. 20.09.2020 to 03.10.2020 but he failed to upload the deficient documents in the e-dossier. Hence, his candidature is rejected for being overage.
