GRADE-II (DASS) (POST CODE 81/17)
IN SERVICES DEPARTMENT

1. The DSSSB vide its Advertisement No. 03/17 with closing date 21/11/2017, addendum dated 09/07/2019 and corrigendum to addendum dated 20/03/2020 had advertised 266 vacancies (UR-135, OBC-78, SC-34, ST-19 including ExSM-48, Sport Person-11, OH-2, HH-07, VH-07) for the post of Grade-II (DASS) in Services Department under Post Code 81/17. Board Conducted Tier-I written examination for recruitment in respect of this post from 16/07/2019 to 19/07/2019 and 22/07/2019 to 25/07/2019. The online Tier II examination was held on 08/11/2019.
2. Vide Notice No. 1070 dated 12/10/2020 the marks statements of the above Post/Post Code were uploaded on the Board's website for information of the candidates and all 2296 qualified candidates (obtained minimum qualifying marks) of Tier II examination were shortlisted to upload their documents in their respective e-dossier link as per Examination scheme published by the Board vide Advertisement No. 03/17 which is reiterated as *"For the Post of Grade II (DASS), based in the Merit on Tier II examination candidates will be instructed to upload their documents on the website of the Board. For candidates found eligible after verification of documents, numbering 1.25 times of vacancies, exit exam shall be conducted so as to fill vacancies and prepare waiting panel. All those qualify in Exit Exam/Writing Skill Test shall be provisionally selected or shall be part of the waiting panel as per the vacancy."*
3. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in two Tier written examination for UR Category Candidate is 40%, for OBC Candidate is 35% for SC/ST/PH candidate is 30% and for EXSM category candidate is 5% relaxation in their respective categories subject to a minimum of 30%.
4. The e-dossier link was activated from 19/10/2020 to 02/11/2020 by the Board. The candidate uploading e-dossier were directed to ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 21/11/2017. Further, it was also conveyed to the shortlisted candidates that if any candidate fails to upload the e-dossier during above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground. Out of 2296 candidates shortlisted for uploading documents in e-dossier link, 2132 candidates uploaded/submitted their e-dossier in between 19/10/2020 to 02/11/2020 and 164 candidates did not uploaded their e-dossier within prescribed time limit.

5. Vide Notice No. 1070 it was also informed to the candidates that Notice for shortlisting of eligible candidates for appearing in Exit Exam/Writing Skill Test in the post code 81/17 will be issued separately, after proper examination of documents submitted by the candidates and being found eligible as per Requirements of RR, various DoPT guidelines and other requirements advertised by the Board, as per their merit on the basis of marks obtained by them in Tier II Exam held on 08/11/2019
6. Now, based on the performance in Tier-II written examination held on 08/11/2019, following 429 candidates found eligible after preliminary verification of documents, numbering 1.25 times of vacancies as detailed below have been provisionally shortlisted to appear in Exit Examination/ Writing Skill Test (Qualifying in nature) subject to correctness of the information furnished by the candidates in their online application forms and documents uploaded in their respective e-dossier. The shortlisted candidates shall be called for Exit Exam separately.

7. Since deficient documents have not been re-called from the candidates as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates' shortlist for appearing in Exit Examination does not entitle them to any right to the post.
8. Only those candidates have been considered in OBC Category who have declared that they had obtained their caste certificates from Delhi State in their online examination form.
9. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates and also who were shortlisted in UR Category for Tier II examination have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
10. Those Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates in Tier II Examination, but were shortlisted for appearing in Tier II examination in their respective categories vide Notice No. 824 dated 01/10/2019 have been considered in their respective category under Post Code 81/17.
11. Following 11 candidates having roll no. 12321001668, 12321001360, 12321001511, 12321000051, 12331000299, 12321000812, 12321001534, 12321000226, 12321001472, 12321001269 and 12321001222 have been provisionally shortlisted in UR Category to appear in Exit Examination subject to further examination of their respective documents.
12. Following 07 candidates having roll no. 12321000036, 12321001467, 12321000622, 12321001832, 12331000413, 12321001562 and 12321000520 have been provisionally shortlisted in OBC Category to appear in Exit Examination subject to further examination of their respective documents.
13. Following 01 candidate having roll no. 12321000389 has been provisionally shortlisted in SC Category to appear in Exit Examination subject to further examination of his respective documents.
14. Following 02 candidates having roll no. 12331000525 and 12321001485 have been provisionally shortlisted in ST Category to appear in Exit Examination subject to further examination of their respective documents.
15. Following 01 candidate having roll no. 12331000049 has been provisionally shortlisted in OH sub-category to appear in Exit Examination subject to further examination of his respective documents.

16. Following 02 candidates having roll no. 12331000089 and 12331000102 have been provisionally shortlisted in HH sub-category to appear in Exit Examination subject to further examination of their respective documents.
17. Following 01 candidate having roll no. 12331000091 has been provisionally shortlisted in VH sub-category to appear in Exit Examination subject to further examination of his respective documents.
18. Following 04 candidates having roll no. 12321001530, 12321000794, 12331000431 and 12321000408 have been provisionally shortlisted in Sports Persons sub-category to appear in Exit Examination subject to further examination of their respective documents.
19. Following 13 candidates having roll no. 12321000500, 12321001679, 12321000218, 12321000903, 12321000193, 12321000904, 12321000169, 12321000089, 12321000076, 12321000114, 12321000483, 12321001519, 12321000653 have been provisionally shortlisted in ExSM sub-category to appear in Exit Examination subject to further examination of their respective documents.
20. In respect of above mentioned **42 candidates (UR-11, OBC-7, SC-1, St-2, OH-1, HH-2, VH-1, Sports Person- 04 and EXSM-13)** whose documents are deficient/further examination of documents are required to take a decision regarding their candidature in post code 81/17, a Notice will be issued separately directing to upload, if required by the Board, their deficient documents/all requisite/applicable documents etc., if any, through the e-dossier module in stipulated time.
21. The Notice is subject to the outcome of OA No. 1390/2019, M.A. 2517/2019, O.A. No. 1376/2020, M.A. 1719/2020, O.A. No. 2384/2019, M.A. 3881/2019 and any other Court Cases pending in various courts related to this Post.
22. The category wise marks scored in Tier II Examination held on 08/11/2019 by the last candidate provisionally shortlisted for appearing in Exit Exam/Written Skill Test are as under:-
